Para 1.20	Like many organisations, West Bristol Concert band had been significantly affected by the COVID-19 pandemic. This prevented in-person rehearsals for the majority of this financial year. During this time the Band organised monthly Zoom social events to keep the community going. This had a particular impact on the members who were considered 'at-risk' and whose normal social activities had been severely affected by the pandemic. Since government restrictions were lifted, West Bristol Concert Band, in conjunction with the rehearsal venue, restarted weekly face-to-face rehearsals in August 2021, and planned their next performance. Rehearsals and performances benefit members by providing a creative outlet, a safe space for learning and improving musical skills, and building community and friendships between members.

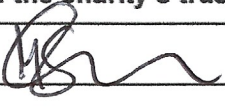
