Objectives and Activities

Relief of individuals aged 16-30 living in England and Wales who have suffered the death of a parent or parents.

Activities for the public benefit include:

- Signposting to grief support services.
- The creation of original grief support content, including personal stories, life experience and advice from our trustees and wider community.
- Creating new and sharing existing educational resources.
- Establishing a supportive and empathetic community.
- Advocacy and raising awareness for our cause.
- Fundraising event and activities.

The trustees have complied with the duty in section 4 of the Charities Act 2006 to have due regard to the public benefit guidance published by the Charity Commission.

Achievements and Performance

It's Time officially commenced activities on 13/01/2021.

Initial focus was on setting out the charity's year one objectives, and establishing the supporting infrastructure required to deliver our charitable services moving forward. This included the appointment of the board of trustees, the delegation of operating roles and responsibilities and completion of various administrative requirements.

A full public, social media, and website launch took place in May 2021.

The first key objective was to provide a signposting function for our community to access a bank of existing grief focused support resources all in one place.

We supplemented this with our own content, including a "Talking About Loss" interview series, as well as various blog posts concerning the topic of losing a parent. These featured the personal stories and experiences from members of our community, ambassadors, and trustees.

We organised and delivered the incredibly successful "Walk in Memory" event, in September 2021, the charity's first dedicated fundraising event, which encouraged our community to raise sponsorship for a 15km run or walk in memory of their loved ones. Our fundraising activities more than doubled our expectations of circa £10,000 in year one.

Plan for the future

It's Time will continue to develop innovative resources and techniques with a tailored approach to supporting young people (16-30) who have experienced the loss of a parent or parents. Furthermore, helping their family, friends, educational establishments, and employers to best support their needs.

Our aim is to improve and expand our services, via the publication of free to access "help guides" for sixth-forms, colleges, universities, as well as mini online learning courses and a peer mentoring scheme.

We plan to recruit a dedicated operations and fundraising employee and have a schedule of future fundraising events in place, including a charitable golf day.

Financial Review

For the period ending 31 December 2021, the charity received total income of £29,849. The total expenditure incurred amounted to £1,237, resulting in a total net income for the period of £28,612.

The charity's principal sources of funds were fundraising activities, events, individual donations, corporate donations, and grants.

Reserve Policy

As a newly formed charity, It's Time does not currently hold any reserves.

First year operations have provided an indication of the appropriate level of reserves required to sustain operations and charitable activities moving forward and will be set accordingly in subsequent financial years.

Structure, Governance and Management

It's Time operates as a CIO and is controlled by its constitution governing document. The trustees will continue to maintain governance standards in order to improve transparency and accountability.
