Objectives and Activities

Relief of individuals aged 16-30 living in England and Wales who have suffered the death of a parent or parents.

Activities for the public benefit include:

- Signposting to grief support services.
- The creation of original grief support content, including personal stories, life experience and advice from our trustees and wider community.
- Creating new and sharing existing educational resources.
- Establishing a supportive and empathetic community.
- Advocacy and raising awareness for our cause.
- Fundraising event and activities.

Achievements and Performance

It's Time had an incredibly successful second year of operations, achieving and surpassing our objectives and smashing our fundraising target.

We launched our incredible online community via the Mighty Networks platform, helping young adults to connect with others who have experienced a similar loss, whilst providing resources to help them navigate the unique challenges they face. A key content feature is our "It's Time to Talk" video miniseries, covering topics including "Health Anxiety", "Career Advice" and "How to Talk About Losing a Parent/s".

We commissioned original research via YouGov surveys and social media polls, gathering valuable insights and trends within our community that have helped It's Time to tailor and enhance our support offering, whilst raising awareness of our communities' specific needs.

Valuable connections were established with several large employers, Universities and Colleges, with It's Time providing free access to our new bespoke "help guides" assisting them to improvement their grief support to the young adults in their care.

We also collaborated with a number of other charities operating in the grief space to create new and promote existing content contributing to the collective resources available to our shared community.

It's Time reached a landmark milestone, recruiting our wonderful first full time employee, a "Social Media & Online Community Executive" facilitating dedicated, effective and efficient creation and management of our content. Furthermore, we received outstanding support and contributions from several interns and a host of volunteers without whom It's Time wouldn't be where it is today.

Plan for the future

It's Time will continue to develop innovative resources and techniques with a tailored approach to supporting young people (16-30) who have experienced the loss of a parent or parents. Furthermore, helping their family, friends, educational establishments, and employers to best support their needs.

We will improve and expand our services, starting with the launch of online "Meet n Grief" peer-to-peer support, offering occasional face-to-face sessions, whilst continuing to release unique social media and website content and resources, as well as undertaking, collating and publishing bereavement data and research.

It's Time is committed to furthering its collaboration and relationship with Employers, Educational institutions and other charitable organisations in the sector, to deliver the best possible support to young people.

To assist our operations, we plan to recruit a "Fundraising & Operations Manager", It's Time's second full time employee, as well as offering numerous internships and volunteer opportunities.

We have many exciting fundraising events planned for 2023, with committed fundraisers lined up, including five entrants set to run in the London Landmarks Half Marathon.

Financial Review

For the period ending 31 December 2022, the charity received total income of £71,964. The total expenditure incurred amounted to £18,318, resulting in a total net income for the period of £53,646.

The charity's principal sources of funds were fundraising activities, events, individual donations, corporate donations, and grants.

Donations were predominantly collected via JustGiving, which handled all additional Gift Aid contributions, with some direct donations made to the It's Time Current Account.

Reserve Policy

It's Time does not currently hold any reserves. However, the first two years operations have provided an indication of the appropriate level of reserves required to sustain operations and charitable activities moving forward. Reserves will be set accordingly in subsequent financial years, to cover between three months fixed costs, to be agreed at the September 2023 AGM.

Fundraising

We cannot thank our amazing fundraisers enough for going above and beyond to help It's Time surpass our annual target.

The year featured many stand out events and achievements from our supporters and Trustees including,

- "Ride to Riga" a 2200km cycling challenge between London and Latvia, receiving a feature on ITV News London.
- "Southwest Coastal Path Challenge" a 1,015km walk from Minehead to Poole.
- A charity golf day and auction at Brookmans Park Golf Club

- Entrants in the London Marathon 2022
- Various individual and corporate events and donations
