Objects: (1) TO RELIEVE FINANCIAL HARDSHIP AMONG THE POOR, THE DISABLED, THE ELDERLY AND PEOPLE IN NEED, BY MEANS OF, BUT NOT EXCLUSIVELY, MAKING GRANTS FOR PROVIDING OR PAYING FOR ITEMS, EQUIPMENT, TREATMENT, SERVICES AND FACILITIES, SUCH AS FOOD AND OTHER NECESSITIES FOR THE BENEFIT OF THE SAID PERSONS;(2) TO ADVANCE EDUCATION FOR THE BENEFIT THE GENERAL PUBLIC BY MEANS OF, BUT NOT EXCLUSIVELY, THE PROVISION OR THE ASSISTANCE IN THE PROVISION OF EDUCATIONAL ACTIVITIES AND FACILITIES, SUCH AS A SUPPLEMENTARY SCHOOLS AND ADULT EDUCATION CLASSES FOR PUBLIC BENEFIT;(3) TO PROVIDE OR ASSIST IN THE PROVISION OF FACILITIES IN THE INTERESTS OF SOCIAL WELFARE FOR RECREATION OR OTHER LEISURE TIME OCCUPATION OF INDIVIDUALS WHO HAVE NEED OF SUCH FACILITIES BY REASON OF THEIR YOUTH, AGE, INFIRMITY OR DISABILITY, FINANCIAL HARDSHIP OR SOCIAL CIRCUMSTANCES WITH THE OBJECT OF IMPROVING THEIR CONDITIONS OF LIFE.
