**Activities:** R World funds development projects in north-east Malawi in the small village of Chitimba. R World works with the Brown Munthali Foundation (BMF), a registered NGO based in Malawi, and focuses mainly on education projects with some funds being allocated for health and environmental purposes. The main project has been a library and R World continues to donate funds for this purpose.
