Objects: 1 THE ADVANCEMENT OF THE CHRISTIAN FAITH IN ACCORDANCE WITH THE BASIS OF FAITH AS SET OUT IN APPENDIX 1 PRIMARILY BUT NOT EXCLUSIVELY WITHIN CHEAM, SUTTON, SURREY AND THE SURROUNDING NEIGHBOURHOOD; AND2 THE ADVANCEMENT OF EDUCATION; AND 3 SUCH OTHER CHARITABLE PURPOSES AS SHALL, IN THE OPINION OF THE CHARITY TRUSTEES, PUT INTO PRACTICE THE CHRISTIAN FAITH IN ACCORDANCE WITH THE BASIS OF FAITH, PROVIDED THAT THE ADVANCEMENT OF SUCH PURPOSES MUST BE UNDERTAKEN IN A MANNER THAT IS CONSISTENT WITH THE BASIS OF FAITH AS SET OUT IN APPENDIX 1 AND ETHICAL STATEMENTS AND DOCTRINAL DISTINCTIVES, IF ANY, AS MAY BE ADOPTED AND AMENDED BY THE CHURCH FROM TIME TO TIME IN ACCORDANCE WITH THE PROVISIONS OF THE CHURCH REGISTER OF STANDING ORDERS.

Activities: Sunday services open to the public for worship, bible teaching, sacraments of communion and baptism. Performance of weddings, dedications, and funerals. Young peoples activities including sunday School, Youth Clubs, and annual 'Holiday Bible Club' for children. Weekly groups for Mothers and Todddlers. A pre-school for children 2-5. Pastoral care. Premises made available to community groups.
