TO ADVANCE EDUCATION FOR THE PUBLIC BENEFIT IN PARTICULAR BY PROVIDING TRAINING, WORKSHOPS AND OTHER EDUCATIONAL ACTIVITIES IN THE SUBJECTS OF HORTICULTURE, FOOD GROWING AND OTHER RELATED TOPICS.3. TO PROMOTE FOR THE BENEFIT OF THE PUBLIC THE CONSERVATION, PROTECTION AND IMPROVEMENT OF THE PHYSICAL AND NATURAL ENVIRONMENT OF A COMMUNITY GARDEN IN CLAPHAM BY PROMOTING BIOLOGICAL DIVERSITY.

Activities: BBA is a volunteer-led organisation based on Clapham Common, formed to promote environmental sustainability, food growing and the support of wildlife. BBA has three growing spaces including a large community garden with a field kitchen. These provide people with an opportunity to get outdoors to learn, share and practise horticultural skills, meet people and be at one with the natural world.
