Objectives and Activities

Milford Baptist Church was registered with the Charity Commission as a CIO on 26 January 2021. Prior to this date Milford Baptist Church functioned as an unregistered and unincorporated charity. After registering as a CIO the period there was a delay, due to the need to avoid a cessation event with the Baptist Pension Scheme, in transferring the activities, assets and liabilities of the unincorporated charity to the CIO. This transfer was not completed until 10 November 2021 and so during the year ending 30 September 2021 the CIO had no activities, assets and liabilities.

The charity's objectives remain as:

1. The advancement of the Christian faith according to the principles of the Baptist denomination
2. The church may also advance education and carry out other charitable purposes in the United Kingdom and other parts of the world.

The trustees have had regard to the guidance issued by the Charity Commission on public benefit.

Achievements and Performance

The charity had no activities in the period to 30 September 2021 to report on.

Financial Review

During the period to 30 September 2021 the charity had zero assets, liabilities, income and expenditure.

Structure, Governance and Management

The charity has an association constitution and is incorporated as a CIO. The trustees' primary role was to ensure the completion of the transfer of activities, assets and liabilities whilst maintaining the activities of the unincorporated charity.

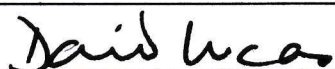

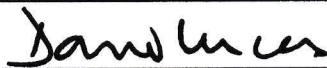
