TO ADVANCE IN LIFE AND TO RELIEVE THE NEEDS OF ORPHANED AND VULNERABLE CHILDREN BY THE PROVISION OF GRANTS TO CHARITIES OR ORGANISATIONS WORKING WITH ORPHANED OR VULNERABLE CHILDREN AND THEIR FAMILIES OR CARERS.3. THE RELIEF OF THOSE IN NEED, BY REASON OF YOUTH, AGE, ILL-HEALTH, DISABILITY, FINANCIAL HARDSHIP OR OTHER DISADVANTAGE BY THE PROVISION OF GRANTS TO CHARITIES OR ORGANISATIONS WORKING WITH SUCH GROUPS.
