Aims and Objectives

Qalb Connection aim to alleviate poverty and suffering in third world countries. Qalb Connection raise funds through social media platforms, some advertising but mostly from word of mouth through family and friends.

Our objectives are to invest in clean drinking water projects, housing restoration projects and to provide food packages to alleviate poverty in the short term. Qalb Connection also invest in individuals to support them to self-sufficiency this has been in the past by providing sewing machines, farm animals such as chicken, buffalo and other cattle.

Activities during year ended 31 January 2024 were:

Monies were collected via word of mouth and social media. Over 400 families received food packages from us.

A charity cricket match was played in order to raise funds. Food stalls were set up and monies from sales were collected.

A family fun day "Mela" was organised for August 2023 and donations were collected from stall holders and attendees

All funds are raised by volunteers and no costs for fundraising are borne by the charity.

Activities for year ending 31 January 2025:

Activities will broadly be the same as those for 2024.

A family fun day is planned for August 2025 where the local community can hold stalls to sell various products including home cooked snacks, toys, interactive games etc etc
