Structure, governance and management

Al Haseen is registered as a Charitable Incorporated Organisation (CIO) and it was registered as a charity on 9 February 2021.

The charity was established under a constitution, which established the objects and powers of the charitable company.

The directors, who are the trustees in charity law are responsible for the overall management and control of the company working with other persons on an entirely voluntary basis.

Trustees are appointed in accordance with Al Haseen constitution. Once appointed, Trustees are given introduction of the charity and information about its objects, Trustees are also given the copy of the constitution and aims and objective, Role description are issued to each trustee and an induction is given setting out the obligations of a trustee. All trustees are issued with copies of the Charity Commission's guidance.

The trustees meet every 3 months.

The trustees actively review the major risk to which the charity is exposed to on a regular basis, in particular those relating to its operations and finances. The system is established to mitigate these.

Objectives and activities for the public benefit

To advance the Islamic religion in the United Kingdom and globally for the benefit of the public, particularly but not exclusively, by the holding of prayer meetings, lectures, classes, public celebration of religious festivals and distributing literature on the Islamic religion in order to enlighten others about Islam.
