Summary of the main achievements of the charity, identifying the difference the charity's work has made to the circumstances of its beneficiaries and any wider benefits to society as a whole.	Para 1.20	In this tax year through the programme, the charity has supported in excess of 250 sessions including as many as 8 people per session on the FiiT for Life programme. In this time, beneficiaries have established long term exercise habits which will help reduce the onset of secondary disease. On completion of the programme, a large number of beneficiaries have opted to stay on the programme or "graduate" to another similar programme through links with the Derbyshire social prescriber network. We have a ~68% retention rate and over 90% engagement/completion rate for the programme. The programme continues to support other projects in work-based health programmes which has seen a positive impact on the health and well being of staff in academic industries (namely Higher education). In addition, the charity continues to support coach education to enhance the offer across the UK. Currently, fitness industry professionals are unable to support individuals with chronic disease without suitable qualification. This often comes at a

		significant cost to the practitioner, and acts as a barrier to supporting those with long term illness. By removing this barrier, more professionals have obtained the knowledge which will allow to them to offer safe, effective, and appropriate exercise prescription to individuals with cancer, long term mental illness, cardiovascular disease, diabetes and post-natal females. The CPD has been endorsed by CIMSPA (Chartered Institute of Sports Management of Physical Activity) to give a higher level of credibility to the education programme.
