Objects: THE OBJECTS OF THE CIO ARE 1. TO PROMOTE SOCIAL INCLUSION OF TIMORESE PEOPLE, WHO ARE SOCIALLY EXCLUDED DUE TO THEIR ETHNIC ORIGIN, IN PETERBOROUGH BY PROVIDING INFORMATION AND ADVICE SOCIAL AND SPORTS ACTIVITIES, MULTICULTURAL EVENTS FOR PUBLIC BENEFIT. 2. TO PROMOTE THE SOCIAL INCLUSION OF TIMORESE PEOPLE, WHO ARE SOCIALLY EXCLUDED IN PETERBOROUGH DUE TO THEIR ETHNIC ORIGIN, BY PROVIDING SUPPORT FOR TIMORESE CULTURAL AND INTEGRATION ACTIVITIES INCLUDING: TIMORESE LANGUAGE CLASSES, TIMORESE ARTS, INCLUDING DRAMA, MUSIC, LITERATURE AND ART INTEGRATION EVENTS TO RAISE AWARENESS OF THE TIMORESE CULTURE FOR PUBLIC BENEFIT. NOTHING IN THIS CONSTITUTION SHALL AUTHORISE AN APPLICATION OF THE PROPERTY OF THE CIO FOR THE PURPOSES WHICH ARE NOT CHARITABLE IN ACCORDANCE WITH [SECTION 7 OF THE CHARITIES AND TRUSTEE INVESTMENT (SCOTLAND) ACT 2005] AND [SECTION 2 OF THE CHARITIES ACT (NORTHERN IRELAND) 2008]
