Summary of the purposes of the charity as set out in its governing document	Para 1.17	To advance the practice of British pipe organ building by such means as education, exchange of information and publications for the general benefit of the public and by providing opportunities for members of the public and young people to further their understanding capabilities, competences and skills in matters related to the craft. To promote the preservation of the crafts and traditional techniques used within British pipe organ building to the highest standard, recognised and awarded by the CIO in order to be the central organisation and association within the United Kingdom for continuance of the heritage and progressive craft of British pipe organ building in places of worship, private residencies, schools and public buildings.

Para 1.17 and 1.19	Publication of an annual journal available to purchase through our website, summarising the past year's activity and trends in British organ building, alongside articles on a wide variety of organ building projects undertaken and other technical studies. The IBO includes a level of membership open to members of the public who are interested in the pipe organ. This level of membership is invited to all IBO meetings (other than the AGM). The IBO organises a number of 'meetings' for its members, at which members of the public may attend as guests, in locations

		throughout the UK where recent work on the pipe organ has taken place. These venues generally remain open during the course of our visits which then often attract those members of the public visiting the building at the same time. One of the key objectives noted above is to advance education in the practice of British pipe organ building. The CIO received disappointing news during 2023 of the withdrawal of our Training Provider from our apprenticeship scheme which had been due to commence in September 2023. This has required the Trustees to reconsider how we recruit and train future organ builders into the craft. We plan to hold regular one/two-day training courses primarily aimed at practising members and which ultimately will raise the standard of the craft in the UK. Another of the IBO's objectives is to preserve the craftsmanship of organ building so we are active in working alongside members of the public within congregations throughout the UK in saving pipe organs from being destroyed by helping in the relocation from one venue to another (both within the UK and overseas).

Summary of the main achievements of the charity, identifying the difference the charity's work has made to the circumstances of its beneficiaries and any wider benefits to society as a whole.	Para 1.20	The national and international customer base of the annual journal continues to support and praise the quality of this publication. Involvement in our meetings at Chelsea Old Church, London and both Liverpool Cathedrals were extended to members of the public wherever possible. A successful open workshop was arranged by one of our Trade Supplier members, open to all categories of membership. Until news of the training provider's withdrawal was received in August 2023, work had been ongoing on the establishment of the first national apprenticeship in organ building. This had been dominating much of our trustees' time. After news of the cancellation of support from the Training Provider, we held an Extraordinary General Meeting where future plans were formulated which resulted in plans including: • To reach out to organ builders outside this CIO for training purposes; • The establishment of a sub organisation for Young Organ Builders (under 40 years old); • The use of IBO publicity at organ opening recital concerts (to raise the CIO's profile); • The organisation of workshop visits by organists' associations & others interested in the craft; • Work experience to youngsters considering a career in the craft.. We also formulated a questionnaire to ascertain members' views on specific areas

		requiring further training. We continued with work on the redundant organs service, assisting in the relocation of a number of organs throughout the year. The Chair attended an inaugural meeting of members from several pipe organ related associations, arranged by the Church of England, with a view to improving outreach and the profile of pipe organs generally.
