There was also a training course on blowers and humidifiers, run by one of the IBO's supplier members,</p> <p>During the year attention was also focussed on the initiatives identified at the 2023 Extraordinary General Meeting, especially the formation of a new group – The Young Organ Builders (YOBS) – which is open to any organ builder below the age of 30 and includes non-IBO members. In addition, statistics are to be collected on the number of female organ builders in the craft and discussions about particular issues faced by women organ builders.</p> <p>An amendment to the IBO's Constitution was passed by the membership allowing the Chair to 'reset' his 4-year term on the Board on taking on the role and also allowing the possibility for a further 2 years to that term.</p> <p>Representatives of the IBO attended meetings with other organisations, notably the Church of England, the Royal College of Organists, the GMB Trades Union and the Heritage Crafts Associations. The IBO has also joined the National Churches Trust.</p> |
