During the period of November 2022 to October 2023, The Jack Price Project (JPP) continued to carry out vital work on the ground in Indonesia, principally within Bali. Below are details of some key activities carried out during this time, which align to our purposes and follow our agreed processes. JPP is as important as ever in the region in providing help and support to those in need and we are incredibly proud of what we have achieved.

Key Activities

1) Sports and Recreational Activities: Annual Spend: £1800 - funds used for entrance to programs, fuel, transport costs and rice meal packs, for after activities. All receipts retained.

Our Sports & Rec programs continued and grew back towards pre Covid levels. Soccer, basketball, swimming, dance and Muay Thai activities were held weekly, with great progress made by the kids, across the board. On average, 30 kids attended each week.

2) Aldo's University Degree: Spend: £300. - course fees paid directly to the university. Receipt retained.

Over the past 4 years, we have supported a young man called Aldo, to study a 4 year Economics degree course, paying his tuition fees. He has worked incredibly hard to achieve his goals, whilst also holding down a full time job, to cover his living costs. We are so very proud to announce that he finally completed the course in August 2023. He now has an incredible opportunity to pursue a working career and life that he could only have previously imagined. Congratulations Aldo.

3) Nyong's Kidney Failure: Spend: £750. Funds used for rent (paid directly to landlord), rice, vegetables and other food specific to his new controlled diet. All receipts retained.

In December 2022, one of the kids that we've supported since 2016, was diagnosed with stage 5 kidney failure. The nature of our work here dictates that eventually, we will be faced with and have to deal with devastating situations like this. It was heartbreaking to hear the news. There is no transplant/donor program, like in the rest of the western world. His only option is a donor coming forward from his immediate family. This would be parents and siblings only. We of course hope that a family member will come forward and donate and will continue to monitor the situation.

He was not able to work and support himself, with no financial help from his family. So we committed to a 6 month period of covering rent and living costs, while he worked out a plan moving forward. Thankfully, he has an incredibly supportive boss, who has allowed him to come back to work part time and further to that, cover his health insurance payments, allowing him to receive dialysis twice a week. He is doing incredibly well and enjoying life again. But it is a ticking clock. We will continue to support Nyong always.

Richard Price, his wife, Claire and daughter Kaitlyn are working closely with all projects and deal directly with all beneficiaries of the charity's resources on the ground in Indonesia. This has enabled the charity to tune in to who is in most need and what The JPP can do to support them.
