1) Sports and Recreational Activities: Annual Spend: £2000 - funds used for entrance to programs, fuel, transport costs and food, for after activities. All receipts retained.

Our Sports & Rec programs continued and are thriving. Soccer, basketball, swimming, dance and Muay Thai activities were held weekly, with great progress made by the kids, across the board. On average, 50 kids attended each week.

Basketball, in particular, is extremely popular in Indonesia and the kids absolutely love it. Our weekly sessions have exploded with the kids benefiting from a qualified coach. Their progress is amazing, with their developing understanding of the game, and also the realisation of the importance of teamwork, responsibility and communication, regardless of the disadvantages of many of the deaf children. Many kids are now representing their schools, as a result of their new skills.

2) Hearing Aids for the kids. Support for education and life enhancement. Annual spend £2000. Funds used to purchase 2 sets of specialist Hearing Aids.

Our 12th and 13th sets of hearing aids for the deaf children in our community. Two teenage girls are the latest additions. They are very different kids. One has a number of disabilities but is still the brightest light that shines in the group. She is so positive and motivated and brightens the lives of everyone she meets. She is trying so hard at everything, despite her difficulties. A true inspiration.

The other is fully able but extremely hard of hearing. The hearing aids have transformed her life. In less than 12 months, she is already able to communicate so much better and even have real conversations with her peers and others, including us!!! Another true inspiration to the world.

3) High School Scholarships. Spend £600. Funds used to pay 1 year of school fees for high school and senior high school for 3 teenagers. 1 girl, 2 boys. Invoices retained.

The teenage girl has been able to start High School as a result of this grant. She would otherwise have been destined to remain at home as a teenage 2nd mother to her younger brothers and sisters. Unfortunately, girls can be left behind in favour of parents using funds to educate the sons. She has 3 brothers, so her chances were slim.

She is thriving in her new school community. With new friends, a support network of her peers, and she is doing really well in the learning zone.

The 2 teenage boys were able to finish their final year at technical college and have graduated and already entered the workplace with meaningful qualifications. They are now equipped with the tools to negotiate the real world despite their hardships growing up in care. Well done, boys. We're very proud.
