Summary of the purposes of the charity as set out in its governing document	Para 1.17	The objects of Global Refugee Aid (GRA) which are for the public benefit, are specifically restricted to the following: a. the relief of poverty and the preservation and protection of health of those seeking asylum or granted leave to remain in the UK or overseas by assisting with provision of aid, accommodation, advice, support and education and by facilitating the integration of refugees and asylum seekers into the wider community. b. to advance the education and training and relieve financial hardship amongst those seeking asylum and those granted refugee status and their dependents in the UK or overseas particularly by signposting to accommodation, employment, education, legal and other advice so as to advance them in life and assist them to adapt and integrate within a new community.
Summary of the main activities in relation to those purposes for the public benefit, in particular, the activities, projects or services identified in the accounts.	Para 1.17 and 1.19	Global Refugee Aid is dedicated to providing vital support and hope to refugees and internally displaced individuals, particularly vulnerable women and girls who have endured unimaginable hardship. Through counselling, maternal health services, and livelihood training, GRA empowers survivors to rebuild their lives and regain a sense of purpose and dignity. GRA focuses on healing the physical and emotional wounds of traumatised women, girls, men, and boys who have fled brutal regional conflicts across East Africa. Two of our key projects include: • Trauma Healing for Refugee Survivors of Sexual Violence in East Africa, offering essential therapeutic care and support to

		survivors to help them reclaim their lives. • Transforming the Physical and Emotional Health of Albino Refugees, providing targeted health and social interventions for this often-marginalized group. In addition to these life-changing initiatives, GRA has expanded its mission to Burundi, where we are addressing a growing and urgent crisis: displaced women suffering from breast cancer without access to proper care or support. These women, many of whom have been internally displaced and lack resources, face devastating health outcomes due to delayed or inaccessible treatment. To combat this crisis, GRA has launched a Breast Cancer Mission in Burundi, mobilising dedicated volunteers' doctors and health professionals from the UK to provide free breast cancer screenings and symptomatic clinics. This initiative not only saves lives but also restores hope, offering compassionate care to women who had none. By focusing on early detection and symptom management, we are giving these women a fighting chance and standing by their side in their journey toward recovery.

Through our targeted projects focused on trauma healing, maternal health services, livelihood training, and specialized healthcare, we have brought meaningful and lasting change to individuals and communities. Despite the challenges posed by the COVID-19 pandemic in the previous financial year, GRA has emerged stronger, leveraging new opportunities and resources to amplify its impact. Our work, supported by generous grants such as that received from the Souter Charitable Trust, has allowed us to expand critical services in Uganda and initiate new life-saving programs in Burundi, demonstrating our resilience and unwavering commitment to our mission. Impact on Beneficiaries Counselling and Trauma Healing - GRA's Trauma Healing for Refugee Survivors of Sexual Violence in East Africa has continued to provide essential counselling services to women and girls who have endured severe trauma. This initiative has supported survivors in their journey toward emotional recovery, enabling them to rebuild their lives with resilience and dignity. Maternal Health Services - We have made significant progress in ensuring access to maternal health services,

		promoting safe pregnancies and childbirths. Our efforts have directly contributed to a measurable reduction in maternal and infant mortality rates, fostering healthier families and stronger communities. 3. Livelihood Training • Through livelihood training programs, we have equipped refugees—particularly women—with the skills needed to achieve financial independence. These programs not only improve individual economic outcomes but also instil a sense of self-reliance and empowerment among participants. 4. Support for Albino Refugees • Our project to Transform the Physical and Emotional Health of Albino Refugees has continued to address the unique challenges faced by this vulnerable group. By providing access to medical care, psychological support, and community advocacy, we are improving their quality of life and fostering social inclusion. 5. Breast Cancer Mission in Burundi • This year, we launched a critical Breast Cancer Mission in Burundi, focusing on displaced women who lack access to healthcare. Thanks to the extraordinary efforts of our medical volunteers, we are offering free breast cancer screenings and symptomatic care to women who might otherwise face this devastating illness without support. Financial Review

Review of the charity's financial position at the end of the period	Para 1.21	Global Refugee Aid has made commendable progress in fundraising during this financial year compared to the previous year. Despite ongoing challenges in securing grants, we have seen a positive shift in our ability to attract donations and engage supporters, which has significantly bolstered our ability to carry out vital projects. This year, GRA was fortunate to receive a £3,000 grant from the Souter Charitable Trust, which has been instrumental in supporting our women's project in Uganda. Additionally, Calvary Chapel Church contributed a generous £600, demonstrating their continued commitment to our cause. A particularly inspiring contribution came from Riverstone Company, which donated £3,150 through an innovative process where one of their staff members donated to GRA, and the company tripled the amount, reinforcing their values of corporate social responsibility and charitable giving. The remainder of our funding was raised through the incredible efforts of volunteers who set up JustGiving and GoFundMe pages. These grassroots campaigns rallied community support for our Breast Cancer Mission in Burundi, enabling us to provide life-saving screenings and care for displaced women suffering from breast cancer. By the end of the financial year, GRA remains focused on fundraising and acknowledges the continued challenges in securing larger grants. However, the strides made this year highlight the resilience and dedication of our supporters, volunteers, and partners. These contributions are not only vital to sustaining our ongoing projects but also provide a foundation for growth as we continue to heal and empower refugees across East Africa.
Statement explaining the policy for holding reserves stating why they are held	Para 1.22	Global Refugee Aid (GRA) recognises the importance of holding financial reserves to ensure the sustainability of our mission and to safeguard the continuation of critical projects in the face of unexpected challenges. Reserves provide a financial

	safety net, enabling the charity to remain resilient and adaptable while maintaining our commitment to supporting refugees and vulnerable individuals across East Africa. For the financial year ending 02/04/2024, GRA received a total income of £12,358. Out of this, we were able to set aside £600 in reserves. This achievement is particularly notable given the significant expenses incurred to sustain and expand our projects. These reserves reflect prudent financial management and a dedication to future-proofing our operations. Financial Overview for the Year • Total Income: £12,358 • Total Expenditures: £10,523 • Reserves Held: £600 Achievements Despite Challenges This year, GRA overcame significant financial challenges to deliver impactful programs: 1. Breast Cancer Mission in Burundi ○ Funds were used to pay for flights and travel expenses for UK doctors and health professionals who volunteered their time to provide free breast cancer screenings and care to displaced women. This life-saving mission has transformed lives and exemplified the power of global collaboration. 2. Uganda Projects ○ We ensured that our ongoing projects in Uganda, including trauma healing and maternal health services, were run effectively and reached those in desperate need of support. Reflection on the Year's Financial Position This year's financial performance marks a significant improvement compared to the previous period (02/04/2022 to 02/04/2023), when GRA faced severe financial constraints and had no incoming funds. Starting the current financial year with only £73, GRA raised £12,358, a testament to

		the renewed focus on fundraising and the generosity of our supporters. While expenditures for the year totalled £10,523, reflecting the cost of delivering vital services and operational expenses, the ability to hold £600 in reserves highlights our commitment to financial sustainability. This reserve ensures that we are better prepared to face unforeseen challenges while continuing to deliver high-impact programs. Looking Ahead Global Refugee Aid remains steadfast in its mission to empower and heal vulnerable communities. The achievements of this financial year demonstrate the charity's resilience, growth, and dedication to its cause. Moving forward, GRA will continue to prioritize strategic fundraising, effective resource allocation, and the expansion of programs to reach even more refugees and displaced individuals in need. Our progress this year has been extraordinary, and with the continued support of our donors, volunteers, and partners, we are confident in our ability to build on this momentum and achieve even greater impact in the future.

This financial year has seen remarkable progress in both fundraising and program delivery, marking a significant improvement from the challenges faced in the previous financial year. This year, GRA successfully raised £12,358, a substantial increase compared to the prior year's financial difficulties, enabling the continuation and expansion of our vital work. Key achievements include the Breast Cancer Mission in Burundi, supported by funds raised through volunteer-led initiatives and corporate partnerships, and ongoing projects in Uganda funded by a £3,000 grant from the Souter Charitable Trust. These accomplishments demonstrate GRA's

	resilience and ability to adapt to changing circumstances to meet the needs of vulnerable populations. Financial Considerations While GRA has made significant strides in fundraising this year, challenges remain in securing sufficient grant funding to match the increasing demand for our services. The £600 reserve held at the end of this financial year is a positive step towards building financial stability, but it underscores the need for continued focus on diversifying income streams and scaling up fundraising efforts. Operational Highlights • Burundi Breast Cancer Mission: Funded by grassroots campaigns and individual donors, this project has provided life-saving care to internally displaced women, showcasing the ability of our team to mobilize resources for urgent needs. • Uganda Projects: The Souter Charitable Trust's grant allowed GRA to sustain its programs in Uganda, including trauma healing and maternal health initiatives, ensuring the continuity of critical services for refugee communities. • Corporate Partnerships: Innovative partnerships, such as the £3,150 donation from Riverstone Company, highlight the potential for leveraging corporate support to strengthen our financial base. Conclusion Despite ongoing challenges in securing sufficient grant funding, GRA is in a much stronger financial position than in previous years. The charity's leadership is committed to further diversifying funding sources, exploring new grant opportunities, and enhancing grassroots fundraising initiatives to ensure sustainability and growth. With renewed momentum and the continued support of our donors, volunteers, and partners, GRA is confident in its ability to maintain operations, achieve its mission, and expand its impact in the lives of refugees across East Africa.

Resolution Requirement: - Apart from the first charity trustees, every trustee must be appointed by a resolution passed at a properly convened meeting of the charity trustees. This ensures that each appointment is formally approved and documented, promoting transparency and accountability within the organization. 2. Consideration of Skills, Knowledge, and Experience: - In selecting individuals for appointment as charity trustees, the current trustees must have regard to the skills, knowledge, and experience needed for the effective administration of the CIO. This ensures that the board comprises individuals with the appropriate expertise to guide and support the charity's mission effectively. These provisions in the GRA constitution ensure a thorough and equitable process for trustee appointments, contributing to the robust governance and successful operation of the organisation.

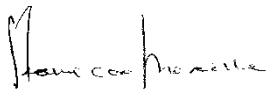
