Structure, Governance and Management

The Charity is governed by an Approved Governing Document. Members of the Church are accepted in accordance with the Constitution which requires them to be or to have been publicly baptised on the profession of faith in Jesus Christ or that persons seeking membership who have not been baptised in the manner described in the Union's Declaration of Principle may at the discretion of the Church Members' Meeting (CMM) be accepted for full membership based on their own public profession of faith.

The CMM normally takes place six times per year and has responsibility for the overall policy of the church. In accordance with the Constitution, the members appoint Elders, who together with the Minister, Church Secretary and Treasurer (who are also appointed by the Members), are responsible for the day to day running of the church's work and witness, and the financial and legal aspects of the charity. All members are encouraged to take an appropriate part in the spiritual and practical tasks involved in the furtherance of the charitable objective.

Relevant matters may be submitted to the Church meeting by the Trustees for guidance, or may be raised by members in the Church meeting for further consideration by the Trustees. Though the Constitution permits decisions to be made at Church meetings by appropriate majorities, the Church seeks to work by consensus wherever possible.

Objectives and Activities

The principal purpose of the charity is the advancement of the Christian faith according to the principles of the Baptist denomination to include the advancement of education, community service and such other general charitable purposes in such parts of the United Kingdom and the world as the Church shall determine.

In order to achieve the principal objective, which is set out above, the Church provides a variety of activities both to its membership and to the community in general. The aim is to show the love of Jesus Christ in both word and deed and to bring people into a closer relationship with Him as living Lord.

Central to the work and witness of the Church is the provision of regular public services of Christian worship. Normally services take place each Sunday at 10.30 am and a monthly prayer meeting on the first Sunday of the month. There are also occasional services at other times which are advertised on the Church Notice Board, in the newsletter and website at <http://www.baptistchurchkilmington.org>. Normally there is a full children's programme during the morning service. The church seeks to be a friendly and welcoming community, and anybody is free to attend any of the services.

The Church runs a series of home groups for the growth of faith and discipleship in the homes of some members, and further details of these can be obtained from the Trustees or Administrator on request, or at the Sunday services of worship.

The Church is responsible for a Toddler Group which meets in the Church premises on a Wednesday morning, with the purpose of assisting the community and demonstrating the love of Jesus Christ; Messy Sparklers a sensory play group for preschool age children and parents/carers. The Church runs various events for young people including

a Holiday Club in August. From time to time the Church runs courses for people interested in discovering more about Christianity. The Church operates systems to ensure that all people working with children and adults at risk are appropriately vetted with regard to the Disclosure and Barring Service. The Trustees have read the Charity Commission guidance on public benefit and is satisfied that the activities outlined above clearly demonstrate that the charity is providing a benefit to the public.

Achievement and Performance

The Church does not measure the success of its programmes only in numbers, including financial numbers but also in less tangible areas like fellowship and encouragement. The Trustees recognise that these are difficult areas to measure but believe that 2022 was a very positive year in the life of the church. The Church has seen its members supporting and reaching out to others in different ways than before. It has also seen the commitment of younger members and others in the technical side of live streaming etc. The Church believes that it will be able to continue to pursue its mission purposes in 2022 with renewed enthusiasm as we return to a form of normality.

There was one baptism, 6 people have been welcomed into membership and two other people joined the church by transfer from another church. Sadly three church members died during the year and others have moved to other churches closer to their homes. At 31 December 2022 the membership stood at 97.

Average attendance at worship services has been increasing over the autumn/winter period this year and a growth in our Sunday children youth and family work. At the beginning of the year the church put in place procedures to help people come back to in-person services by having a clear policy on mask wearing and continuing to allow social distancing for the more anxious. The numbers attending the children and young people's work remain similar to previous years. The Toddler Group continued to be very well supported with 20 families attending regularly.

The church ran a monthly lunch group 'Contact Lunch' for members of the local community with a regular attendance of 30 many of whom do not have particularly close ties to the fellowship. The church hosts the 'Pop-up Post Office' on a Tuesday morning and provides refreshments and friendship/fellowship to everyone who uses the facility. The church has joined the warm spaces initiative for this autumn/winter.

Financial Review

The Church continues to raise the funds which it needs to carry on its activities from within its own membership and congregation. No wider public appeal was made for funds during the year. Gross income for the year was £117,519 (2021 £129,997.) Total receipts of £117,519 (2021 £130,347).

The most significant expense related to the employment costs of Mike Hudson, as Minister of the Church, to lead and co-ordinate the church's activities including the Sunday Services, to provide pastoral care for the congregation and other people, and to equip and encourage the membership in the life, Christian witness and service.

Our Minister completed his time of formal training in June this year, and was ordained and inducted in an awesome service in September.

Financial Review (Continued)

The Church expressed its part in the life of the wider church by making grants to national and international Christian organisations, other churches and societies with Christian aims and objectives compatible with the church's own charitable purposes.

Total expenditure for the year was £91,200 (2021 £93,941) Total payments for the year of £103,494 (2021 £105,373) includes loan repayments of £12,294.

The Church is heavily dependent on its membership working as volunteers in all aspects of the church's activities, many of which are run with little or no impact on the church's expenditure, but nevertheless contribute substantially to the achievement of the church's objectives.

The financial results for the year, together with the summary of the accounting policies adopted are set out in the accompanying financial statements.

The Pension and BUGB Trustees sent a joint communication to your organisation at the end of July 2022 regarding the recent Buy In with Just. As a result of that announcement no further employer debt estimate reports will be published for the time being, although this will continue to be kept under review. Effectively there is no shortfall debt at the present time. However, there will be an administrative cost of £1,000 to process any employees leaving the Scheme.

Reserve Policy

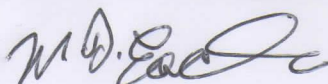
The Trustees have established a Reserves Policy to enable the church to function effectively to meet its obligations in the event of a decline in our income or a major cost.

Having considered the relevant risk of changes in income and expenditure, the Trustees have determined that the appropriate level of reserves is in the range of £18-20K. As at December 2022 the church held total reserves of £95,252 of which £3934 was restricted and £20,000 designated.

Plans for Future Periods

The church has recently discussed adopting a new set of core values. 2023 will consist of exploring those and putting them into practice. Exploring how we might best continue to see Kingdom growth in this season of the church's life

As the church's trustees you are responsible for the preparation of the accounts in accordance with the requirements of the Charities Act 2011 (the Act).

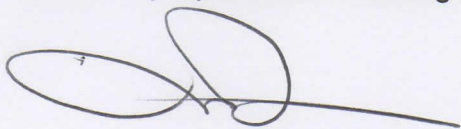

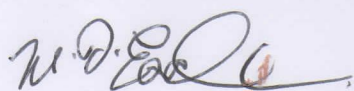
