Report of the trustees

Status and Administration

The Charity, constituted by CIO - Foundation Registered 8 March 2021 and is a Registered Charity.

Charitable Objects

The Charity's objects are:

1. To advance the orthodox Jewish religion in accordance with the statement of faith,
2. To advance education for the public benefit by means of grants to schools, colleges, and educational clubs; and
3. To prevent or relieve poverty, sickness and infirmity by providing grants, items and services to individuals in need and/or charities, or other organisations working to prevent or relieve poverty.

During the year, the Charities have not begun its activities but the trustees have indicated that they hope to get started soon.

The trustees or any person connected with them did not receive any remuneration or expense allowance during the year.

Responsibilities of the trustees

Report of the trustees (continued)

In preparing those financial statements, the trustees should follow best practice and

- b. Make judgements and estimates that are reasonable and prudent.
- c. Follow applicable accounting standards and the Charities SORP, disclosing and explaining any departures in the financial statements.
- d. Prepare the financial statements on the going concern basis unless it is inappropriate to assume that the charity will continue in operation.

The trustees are responsible for maintaining proper accounting records which disclose with reasonable accuracy at any time the financial position of the charity and to enable them as trustees to ensure that the financial statements comply with the Charity Law.

The trustees is also responsible for safeguarding the charity's assets and hence for taking reasonable steps for the prevention and detection of fraud and other regularities.
