## 3. History, objectives and activities of the Charity

The Charity is part of Lions Clubs International Multiple District 105 (Lions MD105) which covers the British Isles. The Club was formed on 1st April 1969 as the Lions Club of Bletchley and achieved Charitable Trust status (Bletchley Lions Club Charity Trust Fund 279584) on 14th April 1980. The Club became registered as a Charitable Incorporated Organisation on 11<sup>th</sup> March 2021 as the Bletchley Milton Keynes Lions Club (CIO), registration number 1193777.

As a Lions Club our purpose is to "serve local communities" and Lions' principles to which the club must adhere include "acting to benefit the public interest".

The Club's objectives include:

- Advancement of citizenship
- Promoting the Voluntary Sector for the public benefit
- Promoting volunteering
- Relief of poverty and relief of those in need
- Advancement of health
- Environment
- Healthy recreation

The Club raises funds each year to enable it to provide grants to deserving causes within Milton Keynes, and the immediately surrounding areas which form part of Aylesbury Vale, Central Bedfordshire and Buckingham are generally given a priority, as well as nationally and overseas via Lions Club International. Grants are made in accordance with the Club's grant making policy.

Since registration as a CIO, the Trustees have paid regard to the Charity Commission's guidance on public benefit in dealing with the objectives and activities of the Club.

The club relies on the surpluses generated from fund raising events and donations from the public to provide the funds with which to carry out its duties. All administrative expenses of the Club are met from donations paid by its members. There has been no change to these policies during the reporting period.

The work of the Club is carried out entirely by volunteers. From time to time as appropriate, the Club works closely with other local and national agencies, other Lions Clubs and Lions Club International to achieve its objectives.

#### **4. Management and Governance Arrangements**

The Club is governed by its CIO documents, the Club's Constitution and By-laws and by the By Laws of Lions Clubs international. The Trustees are appointed as appropriate by the members of the Club and have overall responsibility to ensure that the Club operates in accordance with charity law and the aforementioned Club documents. The day to day running of the Club is overseen by the Club's officers, elected each year by the members. All business is ratified or otherwise by members in general meetings held once a month.

The Club is ably supported by the volunteer services of its members and others.

#### **5. Fundraising and Community Service Activities up to 30<sup>th</sup> June 2025**

During the period ending 30<sup>th</sup> June 2025, the activities of the Club have been seriously impacted by the economic environment post Covid which has adversely affected the ability to raise funds through traditional fundraising activities. During the year activities included collections at local supermarkets, and Quiz Nights. The principal income stream was from donations arising from the Club's members and others, supporting the day-to-day operations of a large Covid Vaccination Centre, generating an income to the Club of over £3,000 during the year. The charity funds also benefitted from a £500 donation from the Club's monthly prize draw

Community activities such as tending therapy gardens at the local hospital and care homes were once again undertaken during the period, involving principally members' time supported by small grants to enhance facilities. The Club also supported a local care home by arranging and funding entertainment for residents

The Club made donations totalling nearly £9,000 to 27 causes and individuals during the year.

There were no serious incidents during the period

The receipts and payment account information presented below is taken from the Charity Commission pro – forma for receipts and payments accounts and it provides the recommended format for the presentation of such accounts and therefore meets the requirements of the Charity Commission. The pro-forma is designed to meet the minimum recommended level of accountability.

Receipts and payment accounts are statements that summarise the movement of cash into and out of the charity during the financial year. In this context “cash” includes cash equivalents, for example bank current and other cash accounts into which money is banked or used to make payments. - Donations made represent the donations and grants made in furthering the objectives of the Club.
- Dues to Lions International and District 105A include those payment associated with constitutional requirements.



Community activities such as tending therapy gardens at the local hospital and care homes were once again undertaken during the period, involving principally members' time supported by small grants to enhance facilities. The Club also supported a local care home by arranging and funding entertainment for residents




## 3. History, objectives and activities of the Charity

The Charity is part of Lions Clubs International Multiple District 105 (Lions MD105) which covers the British Isles. The Club was formed on 1st April 1969 as the Lions Club of Bletchley and achieved Charitable Trust status (Bletchley Lions Club Charity Trust Fund 279584) on 14th April 1980. The Club became registered as a Charitable Incorporated Organisation on 11<sup>th</sup> March 2021 as the Bletchley Milton Keynes Lions Club (CIO), registration number 1193777.

As a Lions Club our purpose is to "serve local communities" and Lions' principles to which the club must adhere include "acting to benefit the public interest".

The Club's objectives include:

- Advancement of citizenship
- Promoting the Voluntary Sector for the public benefit
- Promoting volunteering
- Relief of poverty and relief of those in need
- Advancement of health
- Environment
- Healthy recreation

The Club raises funds each year to enable it to provide grants to deserving causes within Milton Keynes, and the immediately surrounding areas which form part of Aylesbury Vale, Central Bedfordshire and Buckingham are generally given a priority, as well as nationally and overseas via Lions Club International. Grants are made in accordance with the Club's grant making policy.

Since registration as a CIO, the Trustees have paid regard to the Charity Commission's guidance on public benefit in dealing with the objectives and activities of the Club.

The club relies on the surpluses generated from fund raising events and donations from the public to provide the funds with which to carry out its duties. All administrative expenses of the Club are met from donations paid by its members. There has been no change to these policies during the reporting period.

During the period ending 30<sup>th</sup> June 2023 the activities of the Club continued to be impacted by the legacy of Covid 19 resulting in reduced opportunities for traditional fundraising activities. Apart from collections at local supermarkets only the Quiz Night provided a return to normal activity. The Club's members and others, however continued to actively support the day-to-day operations of a large Covid Vaccination Centre, albeit at a reduced level of activity from the previous year but still generating an income to the Club of over £10,000 during the year.

The Club continued with its Bleed Control Kit Initiative and secured £1408 in restricted funding from other agencies of which £1398 was spent within the year. The charity funds also benefitted from a £500 donation from the Club's monthly prize draw.

Community activities such as tending therapy gardens at the local hospital and care homes were once again undertaken during the period, involving principally members' time supported by small grants to enhance facilities.

The Club made donations totalling over £15,000 to 31 causes and individuals during the year.




This resulted in the normal range of fund-raising activities being essentially suspended. The Club's members and others actively participated in supporting the day-to-day operations of a large Covid Vaccination Centre with substantial volunteer time, generating an income to the Club of £29,995 during the year. The Club continued with its Bleed Control Kit Initiative and secured £900 in restricted funding from other agencies to add to the Club's own financial commitment. The charity funds also benefitted from a £500 donation from the Club's monthly prize draw.


Community activities such as tending therapy gardens at the local hospital and care homes were curtailed during the period, only coming active again in 2022.

The annual Rock Chorus fundraising concert was cancelled by the Club due to very low tickets sales. The £1200 restricted funding provided by Marshall Amplification was donated directly to the Rock Chorus choir with the agreement of the donors.

The Club made donations totalling over £19,000 to nearly 40 causes and individuals during the year.


