ANNUAL REPORT OF THE TRUSTEES

FOR THE YEAR ENDED 31st DECEMBER 2025

These accounts run from 1st January 2025 to 31st December 2025.

The Trustees present their report with the financial statement, prepared using receipts and payments, for the year ended 31st December 2025.

Structure, Governance and Management

The charity was registered on 23rd March 2021, and is a Charitable Incorporated Organisation ('CIO'). Four charity trustees manage the affairs of the CIO.

Objectives and Activities

The objects of the CIO are to promote and uphold the principles of the Christian Faith and to relieve poverty, sickness, need or hardship to any person without prejudice in Sierra Leone, or other parts of the world as the trustees may from time to time consider appropriate.

Achievements, Performance and Public Benefit

The CIO continues to work with Pastors and Leaders from around the Kailahun District of Sierra Leone, the work continues spreading from Kailahun to other districts. Over the reporting period the Leaders and Pastors from the communities we are working with continued to come together once a month for training. The transport costs were covered, and a meal was provided. Pastor Ken Fullah and his team continue to work closely with these leaders, visiting them in their respective communities to support and encourage in discipleship.

Lorraine Patience visited Sierra Leone twice during the year, March 2025 and November 2025. In November Alastair joined Lorraine and they travelled together. During the November trip, they, joined with the Africa Youth Award team in Nyanyanhun to monitor the Lifewater Systems that were donated in November 2024. During both visits there were a number of #NoPlaceLeft Trainings carried out that were well attended. Throughout the year Ken and the team continued facilitating #NPL 1-day trainings and 411 Discipleship Trainings in new communities.

The trustees visited 'The Promised Land' to see the progress that is being made. The Poultry House is now completed, and we await to receive the first chickens in Spring 2026.

The #NoPlaceLeft work continues to grow and at the end of 2025 there were 9 Discipleship Groups / House Churches running in communities the CIO are working in. The team on the ground in Kailahun continue to work with these groups leading and training.

The CIO plans to continue expanding the work into new villages and communities during 2026. It is planned that in the Autumn, work will start on building the Discipleship Training centre. Fund raising is underway for this next phase of 'The Promised Land Development'.
