Steve said: “We go directly to people after community tag us on Facebook, and message the charity phone.

We also provide help when contacted by organisations , when people come into community and need support with nothing, such as Police and probation service when people come out of prison, hospital when patients leave , citizens advice , lighthouse alcohol unit, bron Avon housing, employment services, food banks .”

We’ve developed links with the Police and they regularly contact us to garner support.

Community Work....

100s of people in poverty and vulnerable in our community have been helped with clothing, household items, furniture, bedding, children items, prams, curtains and lots more essentials , through our Facebook group page where 2400 people offer items when we ask .
