We have promoted the benefits of feral cats in the rural environment for rodent control. We have provided advice and assistance to members of the public. We liaise with another cat rescue in Ceredigion to provide TNR advice and deal with problem areas where there are feral colonies.

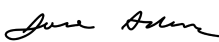
