TO ADVANCE AMATEUR SPORT IN LONDON FOR THE PUBLIC BENEFIT IN PARTICULAR BUT NOT EXCLUSIVELY BY PROVIDING FACILITIES FOR SPORT. TO PROVIDE GRANTS TO OTHER CHARITIES IN THE UK AND CHARITABLE PROJECTS WHICH ARE CONSISTENT WITH OR PROMOTE THE CHARITY'S OBJECTS.
