**Activities:** To establish and run Englefield Village Hall and to promote for the benefit of the inhabitants of the parish of Englefield or for the public at large the provision of facilities for recreation or other leisure time occupation of individuals who have need of such facilities in the interests of social welfare and with the object of improving the conditions of village life of the said inhabitants.
