Trustees' Report **for the year ended 31 March 2025**

The trustees present their report with the financial statements of the charity for the year ended 31 March 2025. The trustees have adopted the provisions of Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019).

OBJECTIVES AND ACTIVITIES

Objectives and aims

" To advance the Christian Faith for the benefit of the Public in accordance with our Statement of beliefs/faith

" The advancement of the Christian religion mainly, but not exclusively, by means of broadcasting Christian messages of an evangelistic and teaching nature.

" To advance the Christian religion in East London particularly and London area in general for the benefit of the public through the holding of church services, prayer meetings, lectures, public celebration of Christian festivals, producing and /or distributing literature on the Christian Faith to enlighten others about the Christian religion.

ACHIEVEMENT AND PERFORMANCE

Charitable activities

All Nations Christian Church (House of Prayer), Destiny Centre, continues to hold in-person worship services on Sundays (3pm to 5pm), however, our Wednesday Teaching and Bible Studies and Friday Prayer Services are held online via Zoom from 7:30pm to 9pm weekly, with the exception of the last Friday of every month where the church holds Half-Night (Vigil) Prayer and Intercessory service to intercede for all People, Leaders, World Missions and Missionaries and Believers across the world from 10pm - 12:15am.

Achievements:

In line with ANCC vision, mission and objects and under the Spiritual Leadership of the church, ANCC continued to engage in fervent Prayers, Monthly Fasting and intercession for our nation and leaders, our communities, the NHS, Healthcare and Social Care workers, families, the Security services, nationally and in our local community. The purpose of this is to share love, bring hope, peace, healing, help and emotional support to people in our communities.

ANCC experienced growth spiritually and has also seen many people participated in our services in-person and online, whereas others have also moved out due to location, however, the charity continues to expand its outreaches.

The impact of the cost-of-living crisis on individuals and families in our community moved the charity in compassion to undertake some acts of kindness and compassions in support of individuals and families affected guided by clearly identified and verified needs as per relevant policies and procedures as a matter of safeguard and due diligence. This is in line with ANCC's charitable activities to provide much-needed material and financial support to the destitute and needy in our communities by making relevant assessments of various situations and conditions.

In support of the amazing work being done by The Great Ormond Street Children's Hospital, ANCC provides monthly financial support and Charitable donation to The Great Ormond Street Children's Hospital. In recognition of its encouragement of, and its contribution to the work of the Free and Independent churches across the nation, a monthly membership donation is also made to support the work of Churches In Communities International (CiC). Through networking with other professionals and ministry partners, ANCC has been able to support many people to get into employment, hence helping them earn income for themselves, provide for their families and contribute to nation-building by paying taxes and making National Insurance contributions as responsible citizens.

Finally, for the third time over the past 4 years, ANCC is again preparing to play a leading role in organising and hosting a team of Leaders and Missionaries from the United States of America - The Good Shepherds Fellowship International (GSFI) for a Three (3) Day National Leaders Conference which brings together churches, local church leaders, youth leaders and music ministries to train, learn and develop strategies for greater community engagements, local and national missions, nation-building, and be inspired to keep being relevant as positive change agents in our communities, nation and the world.

STRUCTURE, GOVERNANCE AND MANAGEMENT

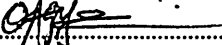
Governing document

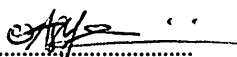

1. ACCOUNTING POLICIES

Basis of preparing the financial statements

The financial statements of the charity, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Charities Act 2011. The financial statements have been prepared under the historical cost convention.

Income

All income is recognised in the Statement of Financial Activities once the charity has entitlement to the funds, it is probable that the income will be received and the amount can be measured reliably.

Expenditure

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

Taxation

The charity is exempt from tax on its charitable activities.

Fund accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

Further explanation of the nature and purpose of each fund is included in the notes to the financial statements.

Hire purchase and leasing commitments

Rentals paid under operating leases are charged to the Statement of Financial Activities on a straight line basis over the period of the lease.
