B) WORKING IN PARTNERSHIP AND COLLABORATION WITH CROSS SECTOR STATUTORY, COMMUNITY AND VOLUNTARY ORGANISATIONS TO DEVELOP MORE EFFECTIVE SERVICES IN THE REPORTING OF RACIALLY AND RELIGIOUSLY MOTIVATED HATE CRIME AND MEETING THE NEEDS OF THOSE AFFECTED BY IT.C) CARRYING OUT RESEARCH, THE USEFUL RESULTS OF WHICH WILL BE PUBLISHED, AND CONSULTATIONS TO MONITOR THE PREVALENCE OF RACIALLY AND RELIGIOUSLY MOTIVATED HATE CRIME, ITS EFFECT ON VICTIMS AND TO DEVELOP APPROPRIATE SERVICES.
