

Bear Flat Environment (BFE) Annual General Meeting 26th October 2022

Annual Report

2021

BFE was registered on 19th May 2021 and so this AGM relates to our operation to the end of financial year December 2021.

Other than setting up the BFE's operation, the prime success of the period was applying for and winning the B&NES CIL Neighbourhood Grant for the rescue of the Queen Victoria Jubilee Fountain on the Gore, amounting to a grant of £5,000. The application envisaged a staged approach to improving the whole of the Gore, with this specific grant request concentrating on the fountain itself, both to rescue it from further decay and to improve its looks.

By the time of the end of 2021, no work had started on the fountain. The pandemic had caused serious availability issues in skilled craftsmen, but Bath Stonemasons honoured an earlier quotation (on which our grant application costs were based) and agreed to conduct the work in early 2022. In addition to this, Wessex Water also gave verbal commitment to deal with the valve station at the back of the fountain.

Although not part of the AGM reporting period, it should be noted that Bath Stonemasons completed the fountain in January 2022, with the fountain being made safe and 'standing proud'. Wessex Water also removed the valve station plus concrete base and made good the ground where the station stood. A plaque has been placed on the rear of the monument, stating when the work was conducted and who the grantor and grantee were. The CIL Neighbourhood Grant has now been signed off with B&NES Council, who seem pleased with the outcome.
