TRUSTEES' REPORT FOR THE PERIOD ENDED 31 MARCH 2023

The trustees' present their report, together with the financial statements for the period ended 31 March 2023.

OBJECTIVES AND ACTIVITIES

The main objects of the charity as set out in its trust deed dated 20 May 2021 are the relief of those in needs by reason of youth, age, ill-health, disability, financial hardship or other disadvantage in Scarborough and surrounding areas by provision of financial support to charities and individuals.

ACHIEVEMENTS AND PERFORMANCE

The trustees are pleased with the performance of the charity in the period and had raised just under £4,500 during the period ending 31 March 2023. This, together with brought forward funds, has enabled the trustees to award local individuals, clubs and organisations with grants to the value of £5,810.

FINANCIAL REVIEW

The charity holds cash at bank of just under £288 at the year-end, all of which is unrestricted funds. These funds are held in order to continue the sponsorship programme as the charity has very few running costs.
