The trustees' present their report, together with the financial statements for the period ended 31 March 2024.

OBJECTIVES AND ACTIVITIES

The main objects of the charity as set out in its trust deed dated 20 May 2021 are the relief of those in needs by reason of youth, age, ill-health, disability, financial hardship or other disadvantage in Scarborough and surrounding areas by provision of financial support to charities and individuals.

ACHIEVEMENTS AND PERFORMANCE

The trustees' report that the charity has not raised any funds in the period ended 31 March 2024. However, they are hopeful that funds will be raised in the following year. The charity was able to fund grants in the year of £288, which was the remaining funds in the charity at the end of the previous year.

FINANCIAL REVIEW

At the year end the charity did not hold any funds in cash at bank. As there are very little running costs of the charity and potential funds will be incoming in the current year, the trustees are not concerned with the lack of funds at the end of March 2024.
