Amin Hussain Trust is established as a charitable organisation with the Charity Commission as a CIO Foundation and is governed by a Constitution. The organisation received its charity status from the Charity Commission on the 21st of May 2021.

The charity, at the moment, is small in terms of income and expenses. Currently, the organisation has four trustees who manage and run the day-to-day operations of the charity, and there are no employees. The trustees ensure, to the best of their ability, that proper due diligence is carried out, end use of funds is monitored, and value for money is achieved in implementing projects.
