There is no running costs so these funds are in place in case of any unforeseen expenditure due to emergency funds needed in Ankoma, Ghana. There have been some issues with the AO bank account with Barclays so they trustees are planning to open a new account, and will be operating with money in PayPal account until issue resolved.
