**Activities:** To promote the arts and heritage for the benefit of the public within the city of Bradford and to advance the arts, in particular the arts of performance, music, drama, poetry reading, sculpture, painting, handicrafts and all other associated arts, by encouraging public participation by supporting the arts and heritage sector through promotion, representation and development.
