Comments:

The financial report format continues to work well. It is easy to check the balances from the bank statements and identify from the account sheet the income and expenditure amounts. I see that you have implemented the suggestion to use the categories as column headers. Unfortunately it does not seem to have reduced your workload. You now have 800+ rows when you had 655 rows in 2023!!! Sorry!!

Would it work better to separate the accounts into monthly income and expenditure? The totals would then link into an annual summary sheet and then into the Financial Report. The advantage is that every entry would automatically update the summaries and the Financial Report.

If you are interested I can send you a draft that I have used in the past for colleagues

We unfortunately lost 2 trustees in 2023 – 1 passed away and another resigned. We made 4 new trustee appointments from our existing volunteers with a good mix of life experience and skills. We retain a core group of wonderful volunteers and have continued to strengthen our relationship with local businesses and organisations, receiving various donations during the year. We worked with local community groups such as Brownies and a senior citizen social group to raise awareness about food poverty. We continued to work with a local business that donates fresh food to us every week. Their staff also volunteer with us and make a big difference to our operation. We started selling our excess fresh food through Too Good to Go, providing a much needed additional income stream for the food bank. One of our volunteers developed an 'app' for us to keep track of who visits us. This

		has been a game-changer for us as we were previously using Google Sheets and printing it off every week – not very practical in the rain!

Between June and the end of 2021, the focus was on ensuring financial security for the food bank and improving how the sessions were run. We increased the number of volunteers with at least 9 new volunteers joining. We distributed the weekly shopping tasks amongst several volunteers. We secured funding for some new racking and stronger tables. We changed how we collected data from the food bank users to minimise abuse of the system and also so we know how often people are using us.

We know that this helped a lot of people that would've otherwise been hungry. Here is one piece of feedback we received: "Thank you so so much for my bags today. We've lived off plain pasta this week and all the treats and food has overwhelmed me. Thank you all so much. I hope one day I can repay the kindness to you all. Happy mummy tears thanks to you guys."
