Objectives and Activities

The object of The James and Shirley Sherwood Foundation is to advance such charitable purposes for the public benefit as the trustees may from time to time in their absolute discretion determine; in particular (but without limitation) the advancement of education; and the advancement of the arts (in particular, but without limitation botanical art), culture, heritage and science.

The charity provides grants to organisations in furtherance of its object. The organisations supported are charitable and may include organisations that are based overseas, including South Africa, Italy, United States of America and Australia.

When supporting overseas organisations, the trustees have regard to the Charity Commission's guidance on grant funding an organisation that is not a charity, as well as HMRC's guidance on payments to overseas bodies.

In addition, although the initial focus of the charity is to provide grants to organisations, it is possible that the trustees will want to make grants to individuals in the future, where to do so would further the charity's object. In doing so, the trustees will have regard to the Charity Commission's guidance on public benefit, to ensure that such grant funding is subject to being satisfied that the level of private benefit to any such individual is acceptable (i.e. that it is necessary and incidental to the charitable purpose).

Statutory declaration on public benefit

The trustees declare that they have complied with their duty to have due regard to the guidance on public benefit published by the Charity Commission in exercising their powers or duties.

Achievements and Performance

The trustees launched The James & Shirley Sherwood Foundation in 2021 following the death of James Sherwood in 2020. The charitable objectives of the Foundation are aligned to the charities that James and Shirley Sherwood have supported personally over several years.

During the period the trustees were pleased to give grants to organisations with which James Sherwood had a close association with as well as funding those organisations which Shirley Sherwood continues to support. A total of thirteen organisations received grants in the current period.

An example of the Foundation's grant making is the grant provided to the Royal Botanic Gardens at Kew. The grant supports the position of a Gallery Assistant at the Shirley Sherwood Gallery of Botanical at Kew. The Gallery Assistant role is vital to the success of the Gallery, and the Gallery

which has recently celebrated its two millionth visitor, enables visitors to connect and celebrate nature through botanical art.

South Africa was a country regularly visited by James and Shirley Sherwood and in the current period the trustees were able to provide grants to three organisations in South Africa.

Financial Review

Dr Sherwood continued to be the principal funding source. During the year, as well as a gift of £179,566 from Dr Sherwood, the Foundation received gift aid of £107,278 on Dr Sherwood's donation made in the previous financial period and both these amounts were added to Dr Sherwood's expendable endowment fund. A transfer of £260,644 was made from the expendable endowment fund to enable grants of £260,172 to be paid to organisations which meet the objectives of the Foundation. As a result the unrestricted income fund at the balance sheet date is £ nil (2022: £8) and the expendable endowment stood at £422,477 (2022: £425,000).

Structure, Governance and Management

The James and Shirley Sherwood Foundation is a charitable incorporated organisation (CIO) registered with the charity commission on 17th June 2021. The governance of The James and Shirley Sherwood Foundation is set out in its constitution.

The constitution requires that there are at least three trustees. The first charity trustees are Dr Shirley Sherwood, Mr Charles Sherwood and Mr Simon Sherwood and they have been appointed for an initial term of five years. The trustees give their time voluntarily and receive no benefits from the charity.

A new charity trustee may be appointed by the members at any time. In selecting individuals for appointment as charity trustees the members must have regard to the skills, knowledge and experience needed for the effective administration of the CIO.

The first charity trustees are also the first members. The only persons eligible to be members are the first charity trustees and any individual who applies to become a member of the CIO and whose application is approved by the members in writing.




**Independent examiner's report to the trustees of The James & Shirley Sherwood Foundation
