

### Trustees' responsibilities statement



### 1. Accounting policies

#### (a) Basis of preparation

The accounts have been prepared in accordance with the receipts and payments basis in accordance with the Charity Commission guidance.

#### (b) Charity status

Waulah Welfare Cardiff was established under a CIO Foundation constitution and is a registered with the Charity Commission under the reference of 1194874. The Trustees are appointed and function in accordance with the Constitution.

#### (c) Fund accounting

The cost of raising and administering such funds are charged against the specific fund. The aim and use of each restricted fund is set out in the notes to the financial statements.

#### (d) Receipts

All incoming resources are included in the Receipt & payment Accounts when the charity actually obtains legally entitled income.

#### (e) Payments

All expenditure is accounted for on payments basis and has been classified under headings that aggregate all costs related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with use of the resources.
