Objects: THE TRUSTEES SHALL HOLD THE CAPITAL AND INCOME OF THE TRUST FUND UPON TRUST TO APPLY THE INCOME, AND ALL OR SUCH PARTS OR PARTS OF THE CAPITAL, AT SUCH TIME OR TIMES AND IN SUCH MANNER TO, OR FOR THE BENEFIT OF, SUCH EXCLUSIVELY CHARITABLE OBJECTS AND PURPOSES IN ANY PART OF THE WORLD AS THE TRUSTEES MAY IN THEIR DISCRETION THINK FIT. THE TRUSTEES MAY IN THEIR DISCRETION, FOR THE PERIOD OF 21 YEARS FROM THE DATE OF THIS DEED, INSTEAD OF APPLYING THE INCOME OF THE CHARITY IN ANY YEAR, ACCUMULATE ALL OR ANY PART OF SUCH INCOME BY INVESTING THE SAME, AND THE RESULTING INCOME, IN ANY AUTHORISED INVESTMENTS AND HOLD THE SAME AS AN ACCRETION TO AND AS PART OF THE CAPITAL OF THE CHARITY, WITHOUT PREJUDICE TO THEIR RIGHT TO APPLY THE WHOLE OR ANY PART OF SUCH ACCUMULATED INCOME IN ANY SUBSEQUENT YEAR AS IF THE SAME WERE INCOME OF THE CHARITY ARISING IN THE THEN CURRENT YEAR.

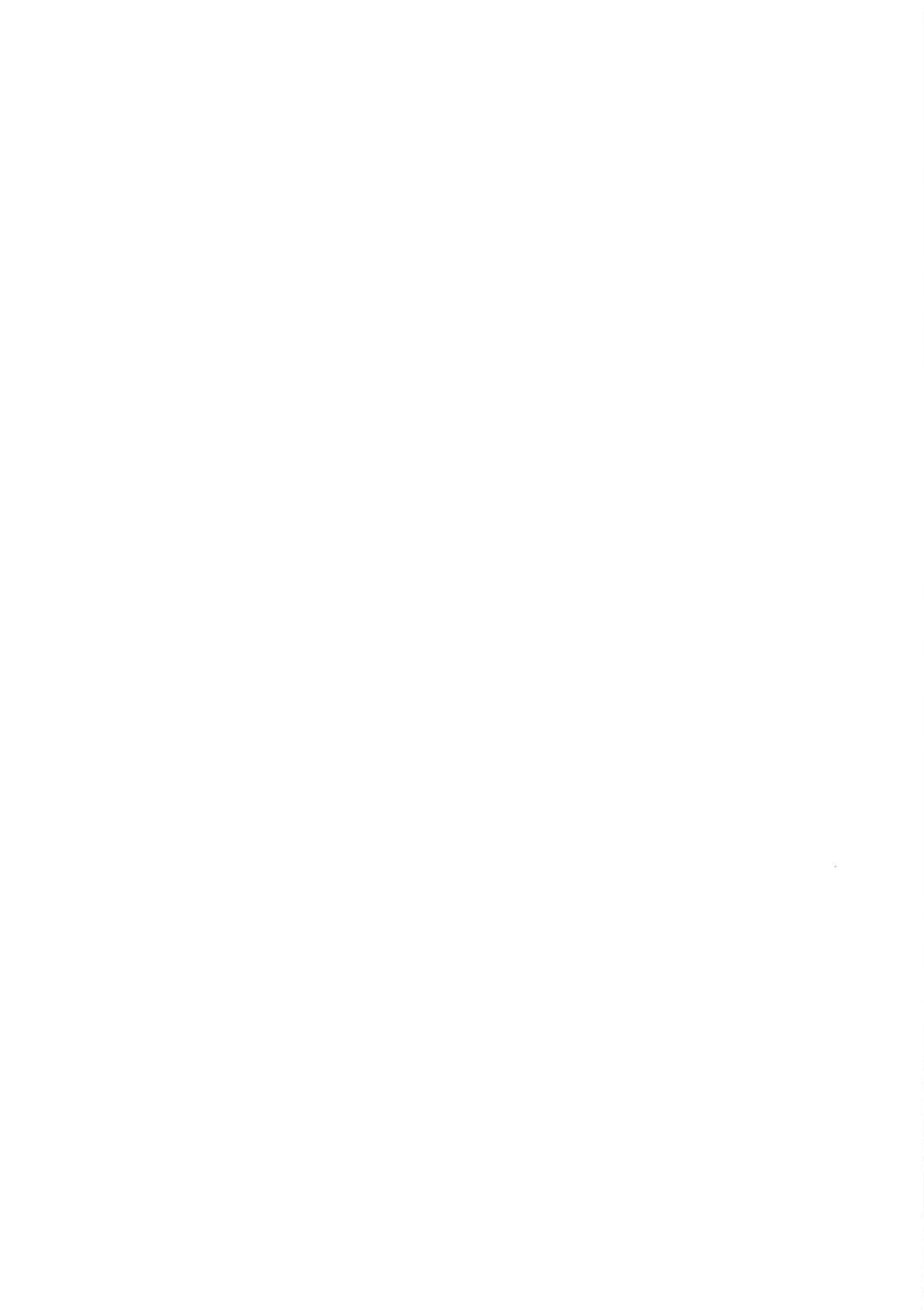

Objectives and Activities

The Charity's objects are: to hold the capital and income of the Trust Fund, to apply the income and all or part or parts of the capital, at such time or times and in such manner to, or for the benefit of, such exclusivity charitable objects and purposes in any part of the world as the Trustees may in their discretion think fit.

The Charity in pursuing its objects made, in the year, charitable donations of £11,850. The Trustees have paid due regard to guidance issued by the Charity Commission in deciding what donations should be made.

Achievements and Performance

The Trustees consider that donations made by the charity substantially help to relieve poverty and advance medical research and assistance.


Financial Review

The financial position of the Charity is shown in the attached Charity accounts. As at 31 March 2022 the reserves held amounted to £28,150. The reserves are considered adequate to fulfil Charity's objectives for the period of six months.

Structure, Governance and Management

The Charity is incorporated and is governed by Trust Deed dated 28 October 2020. The Charity does not consider it necessary to appoint any additional Trustees.
