This included delivering two workshops, three events, and administering three international Tamil language examinations as part of our role as an accredited examination body. These activities directly furthered public benefit by promoting education in Tamil culture, language, arts and heritage in line with our charitable objects.

Para 1.20	During the year, the charity strengthened the provision of Tamil cultural and language education by successfully delivering two workshops, three events, and three international Tamil language examinations. These activities improved the quality and consistency of teaching within Tamil supplementary schools and enhanced access to accredited Tamil language qualifications. As a result, beneficiaries gained increased educational opportunities, improved cultural engagement, and greater confidence in their learning. The wider community also benefited through the promotion of cultural understanding, the preservation of Tamil heritage, and the support of educational standards across supplementary schools.
