Report of the Trustees

For the period from 21st July 2021 to 31st August 2022

The trustees present their annual report together with the unaudited financial statements of the charity for the period from 21st July 2021 to 31st August 2022.

OBJECTIVES AND ACTIVITIES

The charity was established on 21st July 2021 to advance the education of the pupils of Alexandra Primary School by providing and assisting in the provision of facilities and resources as well as to supplement funding provided by the Local Education Authority for education in the school.

The Education Fund primarily collects donations from parents of children of Alexandra Primary School, either as one off or regular donations to provide equipment and resources for the school.

In the current financial year, in addition to the starting sum of £20,000, a further £7,155 has been received and it is anticipated that this income will be spent during the course of the next financial year. The trustees plan to utilise the funds to support the rolling IT enhancement programme and to fund the development of the school's outside areas. It is not anticipated that the fund will hold reserves, rather that donations to Alexandra Primary School from the fund will be made on the basis of funds received.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Governing Document

The charity is a charitable association governed by its Trust Deed dated 27th May 2021 as amended by deed dated 21st July 2021.

Statement of Trustees Responsibilities

The trustees are responsible for preparing the Report of the Trustees and the financial statements in accordance with applicable law and United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice).

The trustees are responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the charity and to enable them to ensure that the financial statements comply with the Charities Act 2011, The Charity (Accounts and Reports) Regulations 2008 and the provisions of its Trust Deed. They are also responsible for safeguarding the assets of the charity and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.
