OBJECTIVES, PURPOSE AND ACTIVITIES

Mission Statement

The objects of the charity are the prevention or relief of poverty in Felixstowe and the surrounding area by providing services to individuals in need and to further such other charitable purposes, according to the law of England and Wales, as the trustees shall decide.

Objectives and Activities for the Public Benefit

The Trustees have considered the Charity Commissions guidance on public benefit when setting the objectives for the year. The Trustees confirm that they have complied with the duty in section 4 of the Charities Act 2011.

ACHIEVEMENT AND PERFORMANCE

The charity launched in April 2021 with three trustees, all of whom are Felixstowe residents of many years, attend local churches and care deeply for the community. Until February 2025 the Senior community outreach worker was a volunteer, also there was one part time, paid member of staff and a number of trained volunteers who are all DBS checked. Thereafter there are two, part time, paid community outreach workers.

The aim is to improve quality of life for families and/or individuals by providing supported signposting/advocacy to specialist services, enabling online form-filling and improving life skills, especially around budgeting and money management. These services are provided free of charge to anyone who resides in Felixstowe (IP11).

The Compass accepts referrals from statutory, voluntary and charitable organisations, so the needs are wide-ranging. The main statutory referral agency in recent times has been GP practices. There have been over 200 individuals/families referred since launch. Increasingly, as we have become better known, we are receiving referrals from friends and family members we have worked with previously.

The team has specialist knowledge around money management, benefits, education, housing and much more. Initial contact can require provision of emergency food and fuel vouchers.

The Compass community outreach workers (and supporting volunteers) work holistically with each service user, within their whole life/family setting. Service-users are assigned a specific outreach worker and always face-to-face appointments – increasingly rare these days. We may work with an individual for a few weeks or, in some cases, a few years. They will remain on the caseload while there is ‘traction’, and can return if their life situation changes.

The Compass has helped income deprived service users financially through a number of funds - namely Rope Trust, Felixstowe Relief Charity, LWAS and Household Support Grant.

In the year to 31st March 2025 unrestricted income was **£24,595** (2024:£8,833) of and unrestricted expenditure was **£19,422** (2024: £19,016), resulting in unrestricted reserves at 31st March 2025 of **£12,176** (2024: £7,003).

Additionally in the year to 31st March 2025 restricted income was **£14,864** (2024:£13,388) and restricted expenditure was **£16,432** (2024: £12,435), resulting in restricted reserves at 31st March 2025 of **£3,376** (2024: £4,944).







The charity launched in April 2021 with three trustees, all of whom are Felixstowe residents of many years, attend local churches and care deeply for the community. The Senior community outreach worker is a paid member of staff, also there is one volunteer outreach worker and an increasing number of trained volunteers who are all DBS checked. The aim is to improve quality of life for families and/or individuals by signposting and/or providing education, training, cultural, recreational, and other appropriate services to anyone in need who resides in Felixstowe and the surrounding areas.

The Compass accepts a referral for anyone in need, so the needs are wide-ranging. There have been over 200 individuals/families referred since launch. Referrals are primarily from schools, social workers and the job centre, also self referrals.

The team has specialist knowledge around money management advice, benefits, education, housing and much more. Initial contact can require provision of emergency food, baby supplies, or fuel vouchers. The Compass has also furnished houses, provided white goods, cleared items to the tip, plumber in washing machines, and carried out gardening.

The Compass community outreach workers (and supporting volunteers) work holistically with each service user, within their whole life/family setting. Typically a service user will have 3 one to one sessions with the community outreach worker. In these sessions needs are identified and forms are filled in (ie, gateway to housing, or additional benefits sought). Typically this leads to identification of missing life skills – such as cooking on a budget, single parenting group, mental health and wellbeing group, money skills, basic maths and english, basic IT, job club, and life skills. The Compass works with Christians Against Poverty, Minding the Gap, Kids Matter and Realise Futures. The Compass has helped income deprived service users financially through a number of funds - namely Rope Trust, LWAS and Household Support Grant.

In the year to 31st March 2024 unrestricted income was **£8,833** (2023:£25,521) of and unrestricted expenditure was **£19,016** (2023: £22,666), resulting in unrestricted reserves at 31st March 2024 of **£7,003** (2023: £17,186). Additionally in the year to 31st March 2024 restricted income was **£13,388** (2023:£22,272) and restricted expenditure was **£12,435** (2023: £18,281), resulting in restricted reserves at 31st March 2024 of **£4,944** (2023: £3,991).



The Senior community outreach worker is a paid member of staff, also there is one volunteer outreach worker and an increasing number of trained volunteers who are all DBS checked. The aim is to improve quality of life for families and/or individuals by signposting and/or providing education, training, cultural, recreational, and other appropriate services to anyone in need who resides in Felixstowe and the surrounding areas.

The Compass accepts a referral for anyone in need, so the needs are wide-ranging. There have been over 200 individuals/families referred since launch. Referrals are primarily from schools, social workers and the job centre, also self referrals.

The team has specialist knowledge around money management advice, benefits, education, housing and much more. Initial contact can require provision of emergency food, baby supplies, or fuel vouchers. The Compass has also furnished houses, provided white goods, cleared items to the tip, plumber in washing machines, and carried out gardening.

The Compass community outreach worker (and supporting volunteers) work holistically with each service user, within their whole life/family setting. Typically a service user will have 3 one to one sessions with the community outreach worker. In these sessions needs are identified and forms are filled in (ie, gateway to housing, or additional benefits sought). Typically this leads to identification of missing life skills – such as cooking on a budget, single parenting group, mental health and wellbeing group, money skills, basic maths and english, basic IT, job club, and life skills. The Compass works with Christians Against Poverty, Minding the Gap, Kids Matter and Realise Futures. The Compass has helped income deprived service users financially through a number of funds - namely Rope Trust, LWAS and Household Support Grant.

In the year to 31st March 2023 unrestricted income was **£25,521** (2022:£38,589) of and unrestricted expenditure was **£22,666** (2022: £24,258), resulting in unrestricted reserves at 31st March 2023 of **£17,186** (2022: £14,331).

Additionally in the year to 31st March 2023 restricted income was **£22,272** (2022:£19,580) and restricted expenditure was **£18,281** (2022: £19,580), resulting in restricted reserves at 31st March 2023 of **£3,991** (2022: £nil).
