Trustees report for the year ending March 2025

Objectives and activities:

The mission of The Mayfly Project UK is to connect, protect and empower children and young people in care through the sport of fly fishing. Using trained volunteer mentors (all enhanced DBS certified), we providing opportunities for children in care to have fun, build self-esteem, learn new skills and develop a meaningful connection with the natural world.

Through our project based programme and structured curriculum, we teach fly fishing, conservation, character building and provide opportunities for the children and young people in care to experience the outdoors with a safe mentor. Our mentors understand that they can't change what children in care have been through, but they can offer an opportunity for them to escape from the pressures of the care system, find solace in nature and develop skills and a love for fly fishing. For some, this can be live changing.

Our aim is to harness the healing power of nature and education in fly fishing to improve the lives of children and young people in care.

Achievements:

- In our fourth season, we continued a campaign to raise awareness of The Mayfly Project UK with both the fly fishing and children's social care communities.
- We maintained our new website to further our mission, reach and national development.
- We introduce our organisation to the wider angling community to gain volunteers, mentors, supporters, donors and partners. We continued to gain supporters through use of social media and traditional press and media coverage.
- We organised and successfully delivered our fourth Reading Project by supporting and training 2no. volunteers to serve in new roles as Co-Lead Mentors.
- With our volunteer mentors, we held 1no mentor training session, delivered 5no 1:1 mentoring sessions and delivered 1no conservation sessions - for a total of 77no project participants over 6no outings.
- We continued to develop our network and work with local councils, social services, case workers, schools and fostering families to identify young people in care for enrolment in our Reading (Theale) project.
- We continued our relationship with three significant fishing and industry sponsors who pledged in-kind support with access to venues and supply of fly fishing equipment.
- We continue to be an approved partner for the Get Fishing for Wellbeing programme - a social proscripting project sponsored by the Angling Trust that recognises the beneficial aspects of angling to boost mental health and wellbeing. The Angling Trust is a not for profit organisation that is recognised by the Government as the National Governing Body for angling in England and Wales, which lends further credibility to our mission and helps with participation development. The programme is supported by NHS Health Services Professionals and Social Prescribing Link Workers.
- To supplement our project manual and training sessions, we engaged in sector relevant professional training for our volunteer Lead Mentors to boost their confidence and skills.

Plans for future periods:

Our primary focus in the year ahead is to maintain consistent delivery of our 2026 Reading Project, ensuring that the quality and integrity of the programme remain central as we continue to support young people in care. Alongside this, we will take a measured and reflective approach to the future shape of the organisation, with a focus on sustainability, resilience, and alignment with our mission. Any development will be carefully paced and informed by organisational capacity and available resources.

The coming year will be an important period of review as we assess our organisational structure and establish a clear, long-term approach that supports stability and resilience. To inform this process, we intend to seek additional skills and perspectives through targeted volunteer roles, where appropriate, to help guide future decision-making and ensure effective governance.

Our programme remains as relevant and necessary as ever. While the immediate impacts of the COVID-19 pandemic have eased, its long-term effects continue to be felt by children and young people in care across the UK. Many continue to experience heightened anxiety, disrupted relationships, and challenges to their mental health and wellbeing, compounded by sustained pressures on education, health, and care services. These challenges are further intensified by the current economic climate, which has placed additional strain on families, local authorities, and support services, and has disproportionately affected vulnerable young people.

At the same time, the organisation is operating within a challenging funding environment. Rising costs and increased competition for limited charitable funding mean that securing sustainable income remains an ongoing consideration. In response, the Trustees remain focused on careful stewardship of resources and maintaining a delivery model that is proportionate, effective, and resilient. Fly fishing continues to offer a uniquely effective and low-cost means of support. Nature-based activities, including fly fishing, are increasingly recognised and recommended by medical and wellbeing professionals, including within the NHS, as beneficial in managing anxiety, depression, PTSD, and trauma-related conditions.

Through our mentoring sessions, participants benefit from the calming influence of time spent near water, increased confidence through learning new skills, and a strong sense of achievement on the riverbank. The joy and pride young people feel when catching a fish on a fly they have tied themselves reinforces self-belief, resilience, and a positive connection to the world around them. In this context, the Trustees believe that maintaining consistent delivery and safeguarding the organisation's capacity to operate effectively represents a responsible and impactful use of limited resources.

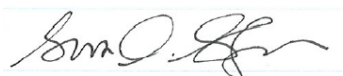

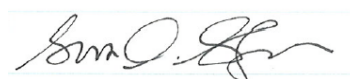

- We registered 2 new mentors for a total of 25 volunteer mentors, held 1 mentor training session, delivered 5 1:1 mentoring sessions and delivered 1 conservation sessions.
- We continued to develop our network and work with local councils, social services, case workers, schools and fostering families to identify 8 young people in care for enrolment in our Reading (Theale) project.
- We continued our relationship with three significant fishing and industry sponsors who pledged in-kind support with access to venues and supply of fly fishing equipment.
- We continue to be an approved partner for the Get Fishing for Wellbeing programme - a social proscripting project sponsored by the Angling Trust that recognises the beneficial aspects of angling to boost mental health and wellbeing. The Angling Trust is a not for profit organisation that is recognised by the Government as the National Governing Body for angling in England and Wales, which lends further credibility to our mission and helps with participation development. The programme is supported by NHS Health Services Professionals and Social Prescribing Link Workers.

- We hosted one fundraising event and attended two events to raise awareness and build support of our mission, the Orvis Flag Day and the British Fly Fair International. We benefitted from cash donations generated by two raffles.
- We engaged regularly with our team of volunteer mentors, providing knowledge and skills training sessions over Zoom calls and in-person meet ups.

Plans for future periods:

Our main focus in the year ahead is to successfully launch our projects and connect with more kids. We will build on our foundations to raise further awareness of our mission, grow our network and gather support organically. We will actively fundraising to support the national development of The Mayfly Project UK so that we can support more children in care in 2024. We plan to recruit two trustees to further enhance our team; a treasurer and an individual experienced with the children's social services / fostering sector.

Our programme is needed now more than ever. The COVID-19 pandemic has had a devastating impact on children and young people in care. With many already suffering the effects of trauma, many more have become further isolated during the pandemic which has impacted their mental health and wellbeing. Fly fishing is the ideal tool for supporting this population because it is currently prescribed by medical professionals (including the NHS) as a tool to help manage PTSD, anxiety, depression and trauma-related disorders. Children that participate in our mentoring sessions experience the calming effects of time spent near water, improved self-esteem from fly fishing success and learning new skills, and they find so much joy when they finally trick a fish with a fly they've tied themselves.

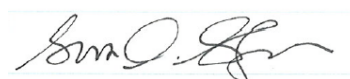

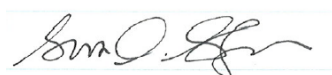

Trustees report for the year ending March 2022

Objectives and activities:

The mission of The Mayfly Project UK is to connect, protect and empower children and young people in care through the sport of fly fishing. Using trained volunteer mentors (all enhanced DBS certified), we providing opportunities for children in care to have fun, build self-esteem, learn new skills and develop a meaningful connection with the natural world.

Through our project based programme and structured curriculum, we teach fly fishing, conservation, character building and provide opportunities for the children and young people in care to experience the outdoors with a safe mentor. Our mentors understand that they can't change what children in care have been through, but they can offer an opportunity for them to escape from the pressures of the care system, find solace in nature and develop skills and a love for fly fishing. For some, this can be live changing.

Our aim is to harness the healing power of nature and education in fly fishing to improve the lives of children and young people in care.

Achievements:

- We launched our first year with a campaign to raise awareness of The Mayfly Project UK with both the fly fishing and children's social care communities.
- We introduce our organisation to the wider angling community to gain volunteers, mentors, supporters, donors and partners. In our first year we gained over one thousand supporters across social media. We aimed to register 8 volunteer mentors and ended our year with 22. We signed on three significant fishing and industry sponsors who pledged in-kind support with access to venues and supply of fly fishing equipment.
- We worked with local councils, social services, case workers, schools and fostering families to identify twelve children and young people in care for enrolment in our first projects at Reading and Epping.
- We received the backing of the Angling Trust, a not for profit organisation that is recognised by the Government as the National Governing Body for angling in England and Wales, which lends further credibility to our mission and helps with participation development.
- We established a PayPal Giving Fund account to enable us to receive donations from private supporters.
- We were publicly nominated and won, the Shakespeare Fund Award — which grants a cash value prize to be applied towards the purchase of equipment which will be used in our projects.
- We attended two events to raise awareness and build support of our mission, the Orvis Saltwater Fly Fishing and the British Fly Fair International. We benefitted from cash donations generated by two raffles.
- We engaged regularly with our team of volunteer mentors, providing knowledge and skills training sessions over Zoom calls and in-person meet ups.
- We organised and planned for our first project season (May-July 2022) with 2no. proposed projects (10 sessions).

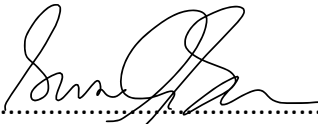
