### **OBJECTIVES AND ACTIVITIES**

To advance the education of the public in the history and heritage of New Brighton by:- Providing access to a historical archive comprising exhibits, objects, photographs and documents which relate to the social, economic and cultural history of New Brighton. Offering Heritage Walks, free of charge. Maintaining an up-to-date Website and Facebook page.

### **ACHIEVEMENTS AND PERFORMANCE**

The Heritage and Information Centre is based at St James Church, Albion Street, New Brighton, where a dedicated space has kindly been allocated to us for a History and Heritage Display. This is open to the public on Wednesdays and Fridays 11am-1pm, and enables us to engage with both visitors and locals on any related queries or issues they may bring. We also use the space to hold meetings with our own volunteers every second Thursday in each month. Each meeting is documented with an agenda and minutes. With the help of our volunteers we have been able to offer Heritage Walks around New Brighton, which have been well supported.

As last year, we took the opportunity to reach out to a wider public at the Wirral History and Heritage Fair which is held at Hulme Hall in Port Sunlight, and we have also continued to work in conjunction with Church representatives in holding exhibitions of local interest.

### **FINANCIAL REVIEW**

Our spending for the year exceeded our income by £1,002. This was largely on account of our purchase of an up-to-date laptop computer at a cost of £510 for the purpose of administrative and promotional work. As stated in the Notes to the Accounts, we do not capitalize any such items costing less than £1,000, so the full amount was charged to this year's accounts. We are satisfied that our spending has been used effectively to promote the aims of the Charity during the course of the year, and the deficit does not give us undue cause for concern given the Funds we have built up from previous years.

#### 1 Accounting policies

##### Basis of preparation

The financial statements have been prepared under the historical cost convention and in accordance with the Statement of Recommended Practice 'Accounting and Reporting by Charities (SORP (FRS102))', issued in January 2019, applicable accounting standards and the Charities Act 2011.

##### Fund accounting policy

Unrestricted income funds are general funds that are available for use at the trustees' discretion in furtherance of the objectives of the charity.

Restricted funds are those donated for use in a particular area or for specific purposes, the use of which is restricted to that area or purpose.

Further details of each fund are disclosed in note 11.

##### Incoming resources

Income derived from events is recognised as earned (that is, as the related goods or services are provided).

##### Resources expended

Liabilities are recognised as soon as there is a legal or constructive obligation committing the charity to the expenditure. All expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all costs related to the category.

Costs of generating funds comprise the costs associated with attracting voluntary income and the costs of trading for fundraising purposes.

##### Fixed assets

Individual fixed assets costing £1,000 or more are initially recorded at cost.

##### Depreciation

Depreciation is provided on tangible fixed assets so as to write off the cost or valuation, less any estimated residual value, over their expected useful economic life as follows:
