The trustees have adopted the provisions of the Statement of Recommended Practice (SORP) 'Accounting and Reporting by Charities' Acts 2011 and in accordance with the Financial Reporting Standard applicable in the UK and the Republic of Ireland (FRS 102) (effective 1 January 2019).

STRUCTURE, GOVERNANCE AND MANAGEMENT

Governing document

The charity is controlled by its governing document, a CIO, and constitutes an incorporated charity.

Risk management

The Board of Trustees is ultimately responsible for the system of internal control and for reviewing its effectiveness. However, such a system is designed to manage rather than eliminate the risk of failure to achieve business objectives, and can only provide reasonable and not absolute assurance against material misstatement of loss.

The Board has reviewed the effectiveness of the system of internal control. In particular, it has reviewed and updated the process for identifying and evaluating the major risks affecting the business and the policies and procedures by which these risks are managed.

OBJECTIVES AND ACTIVITIES

Charitable objects

For the public benefit, the relief of poverty, suffering and distress amongst children in England & Wales and other parts of the world; through the provision of resources and support to the less privileged children in order to assist them in accessing quality education and vocational trainings. The Charity undertook the following activities:

- Paying tuition, accommodation and other needs for children who are currently with BKF Nigeria.
- Currently working with Schools in England and charitable organisations to start educational supports in the UK

FINANCIAL REVIEW

a. RESERVES POLICY

No financial information provided for the past 5 financial periods

Income - the total income for the twelve months under review was **£4,216**

Expenditure - total expenditure in the year was **£4,586**. The Charity recorded an operating deficit for the year of **£370**.

The Trustees have established a policy whereby the unrestricted funds not committed or invested in tangible fixed assets ('the free reserves') held by the Charity should be 3 months of annual expenditure. At this level, the trustees feel that they would be able to continue the current activities of the Charity in the event of a significant drop in funding.

b. PRINCIPAL FUNDING

This is provided mainly through voluntary donations and sponsorship of key events.

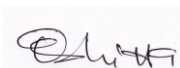

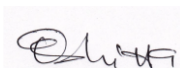

The trustees present their report with the financial statements of the charity for the year ended 31st December 2022. The trustees have adopted the provisions of the Statement of Recommended Practice (SORP) 'Accounting and Reporting by Charities' Acts 2011 and in accordance with the Financial Reporting Standard applicable in the UK and the Republic of Ireland (FRS 102) (effective 1 January 2019).

STRUCTURE, GOVERNANCE AND MANAGEMENT

Governing document

The charity is controlled by its governing document, a CIO, and constitutes an incorporated charity.

Risk management

The Board of Trustees is ultimately responsible for the system of internal control and for reviewing its effectiveness. However, such a system is designed to manage rather than eliminate the risk of failure to achieve business objectives, and can only provide reasonable and not absolute assurance against material misstatement of loss.

The Board has reviewed the effectiveness of the system of internal control. In particular, it has reviewed and updated the process for identifying and evaluating the major risks affecting the business and the policies and procedures by which these risks are managed.

OBJECTIVES AND ACTIVITIES

Charitable objects

For the public benefit, the relief of poverty, suffering and distress amongst children in England & Wales and other parts of the world; through the provision of resources and support to the less privileged children in order to assist them in accessing quality education and vocational trainings. The Charity undertook the following activities:

- Paying tuition, accommodation and other needs for children who are currently with BKF Nigeria.
- Currently working with Schools in England and charitable organisations to start educational supports in the UK

FINANCIAL REVIEW

a. RESERVES POLICY

No financial information provided for the past 5 financial periods

Income - the total income for the twelve months under review was **£780**

Expenditure - total expenditure in the year was **£730**. The Charity recorded an operating surplus for the year of **£50**.

The Trustees have established a policy whereby the unrestricted funds not committed or invested in tangible fixed assets ('the free reserves') held by the Charity should be 3 months of annual expenditure. At this level, the trustees feel that they would be able to continue the current activities of the Charity in the event of a significant drop in funding.

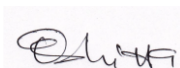

1. ACCOUNTING POLICIES

Basis of preparing the financial statements

The financial statements have been prepared in accordance with the Statement of Recommended Practice: Accounting and Reporting by Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) issued on 16 July 2014 and the Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland (FRS 102) and the Charities Act 2011.

Incoming resources
