DURING THE YEAR, THE CHARITY SECURED INCOME OF £161,772 MAINLY BEING GENERAL DONATIONS AND HAD EXPENDITURE OF £244,048 WHICH WAS MAINLY FOR REPAYMENT OF INTEREST-FREE LOANS TAKEN PREVIOUSLY FOR PROPERTY PURCHASE. GRANTS TOTTALLING £12,979 WERE GIVEN FOR DISASTER RELIEF AND OPERATING COSTS. THE TRUSTEES ACQUIRED SOME INTEREST-FREE LOANS DURING THE PERIOD TO HELP REPAY SOME OF THE LOANS THAT WERE DUE TO BE RETURNED. AT THE END OF THE PERIOD THE CHARITY HAD £205,000 WORTH OF ASSETS RETAINED FOR THE CHARITY USE AND £430,000 FOR INVESTMENT. DURING THE PERIOD, THE CHARITY GENERATED A DEFICIT (NET OF LOANS TAKEN AND REPAYED) OF £11,775 WHICH WAS MET WITH PRIOR YEAR SURPLUSES. THE RESERVES OF THE CHARITY (NET OF ASSETS AND LIABILITIES) WERE £51,678 AT YEAR END. THERE WAS A CORRECTION MADE TO THE PRIOR YEAR RESERVES AMOUNT DUE TO AN ACCOUNTING ERROR. THE CORRECT FIGURE FOR THE PRIOR YEAR RESERVES WAS £63,453 REPRESENTED AS CASH AT BANK. THE POLICY OF THE TRUSTEES IS NOT TO HOLD ANY RESERVES BUT TO USE ANY SURPLUS OR RESERVES FOR FUTURE CHARITABLE EXPENDITURE.
