

Hayat Humanitarian Aid Annual Report Aug 21-Aug22

Hayat Humanitarian Aid was registered with the Charity Commission on 16/08/2021. Our main objectives are to help people in need in different areas. We have partners in Gaza, Jerusalem, Lebanon, Kenya, Pakistan, and Jordan. All these partners have registered charities in their countries, and we receive reports, pictures, and videos for every activity we do. We have 3 Trustees, Ahmed Al-Nashash, Yousaf Wahid, Ashfaq Ali Choudhry; all the trustees are working as volunteers. We don't have any paid employees working for the charity. We have about ten other volunteers who are helping us in charity collection and media coverage.

We responded during the first year of our operation to a few natural disasters in Bangladesh and Pakistan.

Our activities

- Hot meals:** we worked with our partners in Gaza, Jerusalem, Lebanon, Bangladesh, and Jordan to provide hot meals to families in need. Our partners have their kitchens and professionally provided the service, following the health regulations.
Here are the numbers of hot meals and beneficiaries:
Jordan: 1000 hot meals, 1000 families, average number of family members were 5.
Gaza: 3000 hot meals, 3000 families, average number of family members were 5.
Jerusalem (Masjed Al-Aqsa): 400 meals, 400 families, average number of family members were 4.
Lebanon: 500 hot meals, 500 families, average number of family members were 5.
Bangladesh: 500 hot meals, 500 families, average number of family members were 5.
- Food parcels:** we worked with our partners on distributing Food parcels to families in need. The food parcels consisted of essential items like rice, oil, sugar, tea, pasta, and other items. The cost of food parcel varied from £20-£40.
The number of food parcels distributed are as follows:
Gaza: 500 food parcels
Bangladesh: 400 food parcels
Lebanon: 300 food parcels
Pakistan: 100 Food parcels

Jordan: 200 Food parcels

Jerusalem: 200 food parcels

3. **School Stationery:** We realised that there are many students in different countries who can't afford the basic stationary items for the school. Hence, we launched a campaign in 2021 and 2022 for that, alhamdulillah (all praise belongs to Allah) the response was great, so we managed to deliver the following:

Jerusalem: 200 School stationary packages

Jordan: 200 School stationary packages

Gaza: 150 School Stationary packages

4. **Qurbani:** Alhamdulillah, we managed to deliver the Qurbani that the donors contributed during Hajj season in the following countries:

Pakistan: 2

Bangladesh: 8

Gaza: 8

Kenya: 70

Lebanon: 8

5. **Orphans:** We understand the vulnerable situation of Orphans who lost their fathers and find themselves without support, so we launched a campaign to sponsor Orphans in Gaza. Alhamdulillah, a few brothers and sisters supported 30 orphans on monthly basis. The Monthly cost is only £40, which helps meet the basic needs of the orphans.
6. **Winter Packages:** we provided winter packages to families in need in Gaza, Jerusalem, Jordan, and Bangladesh. These packages helped those people cope with the cold weather in their countries. We provided 100 packages to each of the above-mentioned countries.
7. **Zakat:** During Ramadan and other months, there are many brothers and sisters who like to pay their Zakat, which we receive and distribute, i.e. Cash to those who are entitled according to the Islamic way. We distributed about £10,000 in Bangladesh, Lebanon, Jerusalem, Jordan, and Gaza through our charity partners.
8. **Long-term projects:** we worked with our partners in Bangladesh to provide ten sewing machines to families there so they could work and cover part of their financial needs.
9. **Water Pump:** After the crisis of Rohingya, thousands of them became refugees in Bangladesh. One of their needs is clean water, so we launched a campaign of providing water pumps in the refugee's area, Alhamdulillah we managed to establish 30 water pumps, the cost is £250 each.

10. **Future:** we are planning to start working on the needs of our local community here in the UK and see how we can help and improve their situation, mainly in health and education.
11. **Orphanage in Gaza:** We are looking to build an orphanage in Gaza so the orphans that we are sponsoring can find a proper place for their education.
