1. About Hayat Humanitarian Aid

Hayat Humanitarian Aid is a registered charity with the Charity Commission since 16 August 2021. Our main objective is to help people in need in various regions through reliable, trusted local partners. We currently work with partners in Gaza, Bangladesh, Kenya, Pakistan, and Jordan, all of whom are registered charities in their respective countries. For every activity we undertake, we receive detailed reports, pictures, and videos to ensure transparency and accountability to our donors.

1.1 How We Work

We are a volunteer-led organisation. Hayat Humanitarian Aid has three trustees: Ahmed AlNashash, Yousaf Wahid, and Ashfaq Ali Choudhry. All trustees work on a voluntary basis, and we do not have any paid employees, which helps us keep administrative costs to a minimum. In addition, around ten other volunteers support us with charity collections, campaigns, and media coverage throughout the year.

Our model is to partner with reputable local organisations who understand the needs of their communities best. Through these partners, we deliver food, water, education support, orphan sponsorship, Zakat, and emergency relief to vulnerable families.

2. Message from the Chairman

Alhamdulillah, by the grace of Allah and through the generosity of our donors, Hayat Humanitarian Aid continued to grow and serve more people in need during the period from September 2024 to August 2025. The reporting year was marked by both immense hardship in many of the regions we served and by inspiring acts of kindness and sacrifice from our supporters.

In Gaza, with the ongoing humanitarian crisis, ~~your~~ donations enabled us to provide essential support worth £564,234 in the form of hot meals, clean water, food parcels, blankets, mattresses, baby milk, bread, Zakat distribution, orphan sponsorship, Ramadan meals, Eid clothes, tents, food vouchers, and Qurbani. Across Bangladesh, Jordan, Kenya, Pakistan, Rohingya refugee camps, and other regions, we delivered Qurbani, food assistance, water projects, school stationery, and orphan care that transformed the daily lives of many people.

We are particularly grateful for the brothers and sisters who committed to sponsoring orphans in Gaza, allowing us to support 50 orphans with a monthly allowance that covers their basic needs. Our water projects in Rohingya areas provided clean water to many families who previously struggled to access this necessity.

November 2025 marked setting a new initiative where we planned and began to expand our efforts in the UK by launching Hayat Kitchen in November 2025 to serve hot meals to local families in need and homeless people.

3. Our Work by Country

3.1 Gaza

In Gaza, we delivered projects totalling £564,234 during the reporting period. With the help of our partners, we provided hot meals, clean water, food parcels, vegetable parcels, blankets, mattresses, bread, flour, baby milk, Zakat, orphan sponsorship, Ramadan meals, Eid clothes, tents, food vouchers, and Qurbani. This support reached families facing severe hardship, displacement, and food insecurity. Our focus was on meeting immediate needs while also supporting orphans and vulnerable families over a sustained period.

3.2 Bangladesh

In Bangladesh, we implemented projects worth £12,650. These included Qurbani, food parcels, Ramadan meals, and Zakat distribution to families in need. Through our partners, we were also able to support Rohingya refugees with essential services such as food assistance and water projects.

3.3 Jordan

In Jordan, we delivered projects totalling £10,165. Our activities included Zakat distribution, Eid clothes, school stationery, hot meals, heaters, and blankets for families in need. These interventions helped families cope with the high cost of living and harsh winter conditions, particularly refugees and low-income households.

3.4 Kenya

In Kenya, we implemented projects worth £6,250. During Qurbani, we provided 50 sheep and 30 cows, distributing meat to poor families and children in orphanages. In addition, one of our volunteers visited three orphanages, where we distributed ten sewing machines and provided meals to the orphans. These sewing machines support livelihood opportunities and skills development for the older children and carers.

3.5 Pakistan

In Pakistan, we delivered projects valued at £3,545. We provided Qurbani in the form of 20 sheep, which were distributed among poor families. We also distributed hot meals during Ramadan, enabling needy families to break their fast with dignity.

3.6 Rohingya Refugees (Bangladesh)

For Rohingya refugees in Bangladesh, we implemented water projects worth £4,000. We provided 16 water pumps in Rohingya areas, each supplying clean water to at least eight families. These pumps are a vital lifeline, improving health and hygiene for displaced families who have limited access to safe drinking water.

4. Thematic Impact

4.1 Food Assistance

Food security remains one of our top priorities. Through donations received, we delivered hot meals, food parcels, vegetable parcels, bread, flour, and food vouchers in several countries. During the financial year, we provided hot meals on a daily basis, feeding about 400 families a day on average. These hot meals had a great impact on displaced people in Gaza who lost their homes and had no means to provide food for their families. We worked with partners to distribute food parcels containing essential items such as rice, oil, sugar, tea, pasta, and other staples. The cost of each food parcel ranged from £30 to £60, depending on the country and contents.

- **Gaza:** 600 food parcels distributed.
- **Bangladesh:** 300 food parcels distributed.
- **Jordan:** 300 food parcels distributed.

In addition, we provided Ramadan meals and Qurbani meat to ensure families could observe key Islamic occasions without worrying about basic food needs.

4.2 Education and School Support

Many children in the communities we serve struggle to afford basic school supplies. In response, we launched a school stationery campaign in 2024. The response was excellent, and we delivered:

- 200 school stationery packages in Jordan.
- 400 school stationery packages in Bangladesh.

These packages helped children attend school with dignity and better prepared them for learning.

4.3 Orphan Care and Livelihoods

Our orphan sponsorship programme in Gaza supported 50 orphans through monthly contributions of £40 each. This programme covers essential living costs and allows children to focus on their education. In Kenya, our visit to three orphanages included distributing ten sewing machines (ages varying between 15 to 25) and providing meals to the orphans. The sewing machines support small income-generating activities and skills training, helping orphanages become more sustainable.

4.4 Zakat

Throughout Ramadan and other months, many brothers and sisters entrusted us with their Zakat. We ensured this was distributed in cash to those who are entitled, according to Islamic principles. We distributed approximately £32,000 in Zakat through our partners in Bangladesh, Jordan, and Gaza. This support provided immediate relief to widows, orphans, families in debt, and other eligible recipients.

4.5 Qurbani

During the Hajj season, we carried out Qurbani on behalf of donors in multiple countries. The total value of Qurbani donations was £15,000. The number of animals sacrificed in each country was as follows:

- **Pakistan:** 20 goats.
- **Gaza:** 12 goats and 10 cows.
- **Bangladesh:** 5 goats and 1 cow.
- **Kenya:** 50 goats and 30 cows.
- **Jordan:** 2 cows.
- **Rohingya:** 5 goats.

The meat was distributed to poor families, enabling them to share in the joy of Eid.

4.6 Clean Water

During this financial year, we provided thousands of litres of clean water in Gaza. In some months, we provided 200,000 litres a day, benefiting hundreds of families because most of the normal water supplies were destroyed during the war. After the Rohingya crisis, thousands of refugees settled in camps in Bangladesh with very limited access to clean water. To help address this need, we launched a water pump campaign. We provided 16 water pumps at a cost of £250 each. Each pump serves at least eight families, giving them access to clean water for drinking, cooking, and washing.

5. Financial Overview (Summary)

During the reporting period, donor contributions were allocated across several key areas and countries. Major expenditure included:

- **Gaza Projects:** £564,235
- **Bangladesh Projects (excluding Rohingya water):** £12,650
- **Jordan Projects:** £10,165
- **Kenya Projects:** £6,890
- **Lebanon Projects:** £3,200
- **Pakistan Projects:** £3,545

Projects Expenses in Categories:

All trustees and volunteers serve without pay, and we have no salaried staff, which allows the maximum possible portion of donations to reach those in need. Funds are transferred through registered local partners who provide documentation and media evidence for every project. Crucially, only 22% of the Gift Aid received was used to cover operational expenses—the remainder was directed entirely towards our charitable projects. This demonstrates that we proudly uphold our 100% donation policy, ensuring that every pound donated by our supporters goes directly to the people and causes that need it most.

6. Future projects

6.1 Hayat Kitchen (UK)

November 2025:

We began planning and commenced a new initiative to start working more actively within our local community in the UK, focusing on health and education, as well as basic needs. We scheduled our first UK-based project (for basic needs) - Hayat Kitchen, which we set to launch in November 2025. Through Hayat Kitchen, we aimed to provide hot meals to families in need and to homeless people in our local area. This project is set to commence with the support of volunteers and local partners, in line with our commitment to serving both international and local communities.
