Objects: THE OBJECTS OF THE CHARITY (THE "OBJECTS") ARE: A) THE PREVENTION OR RELIEF OF POVERTY IN PARTICULAR BUT NOT EXCLUSIVELY, IN COUNTRIES AND REGIONS AFFECTED DIRECTLY OR INDIRECTLY BY NATURAL AND OTHER DISASTERS; CIVIL COMMOTION OR DISEASE; BY PROVIDING OR ASSISTING IN THE PROVISION OF EDUCATION, TRAINING, HEALTHCARE PROJECTS AND ALL THE NECESSARY SUPPORT DESIGNED TO ENABLE INDIVIDUALS TO GENERATE A SUSTAINABLE INCOME AND BE SELF-SUFFICIENT; AND B) THE ADVANCEMENT OF EDUCATION BY AWARDED SCHOLARSHIPS, MAINTENANCE ALLOWANCES OR GRANTS AT ANY INSTITUTION OF HIGHER OR FURTHER EDUCATION, IN PARTICULAR, FOR EDUCATION PROVIDED IN ACCORDANCE WITH THE TENETS OF ISLAM; AND TO DELIVER THESE PURPOSES IN ACCORDANCE WITH THE PRINCIPLES OF THE ISLAMIC FAITH.

Activities: The prevention or relief of poverty in particular but not exclusively, in countries and regions affected directly or indirectly by natural and other disasters; civil commotion or disease; by providing or assisting in the provision of education, training, healthcare projects and all the necessary support designed to enable individuals to generate a sustainable income and be self-sufficient;
