The trustees at MentorNect confirm that referral has been made to the provisions of Charity Commission's guidance on public benefit, and as such, the objectives and

activities of the Charity are in alignment with the guidance.

The Charity conducts the above by:

Devising the MentorNect6 1-2-1 mentoring programme where mentees have access to an approved MentorNect mentor for a defined period of time at no cost to mentees.

The programme is funded by donations made to the Charity. All proceeds are reinvested into the charity to enable the charity organisation to sustain its charitable activities.

Should mentees desire to have extra sessions, the option to pursue MentorNect+ is available for an extended period. Compared to the previous report, mentees are

currently able to have extra sessions at no cost.

Additionally, liaising and establishing collaborations with educational institutions, and charities to offer educational talks to students, young adults on ways to enhance employability,

and advice on how to improve the overall well-being of young people to ensure that they are equipped to achieve and live a wholesome life.

Loretta Nana Asiedu on her own career and personal development journey, recognised the need amongst young adults to be connected to individuals with expertise

in their chosen career, and extensive life experience to provide them with valuable advice and support through mentoring.

The Charity has made significant contributions to the knowledge and skills of many young adults, particularly in 2020 at the height of

the pandemic where a surge in unemployment and a detrimental effect on well-being was rife.

Presently, the Charity relies on donations and in-house fundraising activities to continue its charitable work with plans to incorporate grants to expand the

organisation's reach in the pipeline.

In line with its constitution, the minimum number of trustees the Charity is permitted is three with no maximum of trustee appointments. All new trustees

are appointed by current trustees and serve for a year with a review conducted mid-term. New trustees will equally have the opportunity to opt for

re-appointment should this be desired.

At the board of trustees' meetings, there is deliberation and decision-making of the overall strategic direction of the Charity. This covers and includes review of new policies,

volunteer management and recruitment, update on the Charity's financial position, its strategic plans to boost mentor and mentee portfolios. Formation of the board remains

as previous year, and no changes amongst the board. No new appointments or removal has occurred since the last report.

All trustees are appointed by a resolution passed at a properly convened meeting of the charity trustees. As part of the trustee recruitment process, all new trustees

undergo an interview with existing trustees to ascertain their motives align with that of the Charity. An agreed Code of Conduct, a role description, useful Trustee information provided by

the Charity Commission - agreed by trustees are provided. Most importantly, the Charity's Constitution is provided for trustees to familiarise themselves with the objects and its rules.

In accordance with the Constitution, all trustees were not paid any remuneration and voluntarily offered their time and expertise freely to the development of the charity.

ACHIEVEMENTS AND FUTURE PLANS

MentorNect aims to make mentoring easily accessible to young adults to improve their wellbeing and provide the adequate skills required to thrive on their career journey.

To obtain this, the charity recognises the need to strengthen and broaden its strategy to succeed in order to increase their chances of improving their employment prospects.

The charity delivered a series of engaging in-person workshops at Harlow College, focused on life sciences and potential career avenues within the sector.

These sessions aimed to broaden students' understanding of the diverse opportunities available in the field and support their career readiness. The workshops reached approximately forty students and contributed to building awareness and aspiration around life science and the importance of mentorship.

Given the resources of the Charity, MentorNect successfully mentored six young adults virtually within the year. Some of whom have gained key advice on how to

approach interviews, entrepreneurial skills, discover self-confidence, existing strengths, and guidance in securing placements. At a stage in the world where

many young people are experiencing challenges in deciding the best career path and how to attain this, our support and guidance were crucial more than ever.

MentorNect conducted its first fundraising event: Step Challenge, this year. The aim of the event was to challenge Trustees to walk 10,000 each day over the

course of a week. Funds were raised through the platform GoFundme and a total amount of £750 was raised.



PRINCIPAL ACTIVITIES

The principal activity of the charity in the 377 day period under review was Mentoring . MentorNect is committed to act as a resource for young people between the ages of 18 and 30 by the provision of accessible e-learning mentorship programs for the development of skills, knowledge, education, employability and capacities as a means of:

- (a) advancing in life and helping young people by developing their skills, capacities and capabilities to enable them to participate in society as independent, mature and responsible individuals; and
- (b) relieving unemployment.

The trustees at MentorNect confirm that referral has been made to the provisions of Charity Commission's guidance on public benefit, and as such, the objectives and activities of the Charity are in alignment with the guidance.

The Charity carries out the above by:

Devising the MentorNect6 1-2-1 mentoring programme where mentees have access to an approved MentorNect mentor for a defined period of time at no cost to mentees. The programme is funded by donations made to the Charity. Should mentees desire to have extra sessions, the option to pursue MentorNect+ is available for an extended period at a highly subsidised rate – all proceeds are reinvested into the charity to enable the charity organisation sustain its charitable activities.

Additionally, liaising and establishing collaborations with educational institutions to offer educational talks to students on ways to enhance employability, and advice on how to improve the overall well-being of young people to ensure that they are equipped to achieve and live a wholesome life.

STRUCTURE, GOVERNANCE AND MANAGEMENT

MentorNect is a registered Charitable Incorporated Organisation CIO under number 1195573. Prior to its incorporation in 2021, the Charity was established after its founder Loretta Nana Asiedu on her own career and personal development journey, recognised the need amongst young adults to be connected to individuals with expertise in their chosen career, and extensive life experience to provide them with valuable advice and support through mentoring.

The Charity has made significant contributions to the knowledge and skills of many young adults, particularly in 2020 at the height of the pandemic where a surge in unemployment and a detrimental effect on well being were rife.

Presently, the Charity relies on donations and in-house fundraising activities to continue its charitable work with plans to incorporate grants to expand the organisation's reach in the pipeline.

In line with its constitution, the minimum number of trustees the Charity is permitted is three with no maximum of trustee appointments. All new trustees are appointed by current trustees and serve for a year with a review conducted mid - term. New trustees will equally have the opportunity to opt for re-appointment should this be desired.

At the board of trustees' meetings, there is deliberation and decision-making of the overall strategic direction of the Charity. This covers and includes review of new policies, volunteer management and recruitment, update on the Charity's financial position, its strategic plans to boost mentor and mentee portfolios.

The trustees would like to express gratitude to Nicola Ann Marie Bogle for assuming position on the board as well as her role as mentor within the organisation. This is following the resignation of Charlotte Valerie Caradot to focus on a new career opportunity.

All trustees are appointed by a resolution passed at a properly convened meeting of the charity trustees. As part of the trustee recruitment process, all new trustees undergo an interview with existing trustees to ascertain their motives align with that of the Charity. An agreed Code of Conduct, a role description, useful Trustee information provided by the Charity Commission - agreed by trustees are provided. Most importantly, the Charity's Constitution is provided for trustees to familiarise themselves with the objects and its rules.

In accordance with the Constitution, all trustees were not paid any remuneration and voluntarily offered their time and expertise freely to the development of the charity,

ACHIEVEMENTS AND FUTURE PLANS

Given the resources of the Charity, MentorNect successfully mentored 10 young adults virtually within the year. Some of whom have gained key advice on how to approach interviews, entrepreneurial skills, discover self-confidence, existing strengths and guidance in securing placements. At a stage in the world where many young people were experiencing the effect of the pandemic, our support and guidance were crucial more than ever.

To ensure that our charitable work reaches as many young adults as possible, the Charity understands the importance of establishing collaborative ties with educational institutions, particularly in the tertiary sector. This has led to securing a working collaboration with the Careers and Employability team at the University of Chester where mentees have been recruited, virtual personal development themed talks have been hosted by the Charity for students. The Charity equally has successfully liaised with the University of Westminster, to participate in its pilot group mentoring scheme where a few of the Charity's mentors lent their expertise and mentored a group of students.

Furthermore, the Charity was pleased to have had the opportunity to attend two virtual career fairs held by the University of West London which was attended by the founder and selected mentors. The appearance garnered interest in the Charity's activities which resulted in the Charity securing mentee signups. The Charity aims to continue on this path and further acknowledge future invitations in a bid to extend its services to many more students who require a mentor with industry knowledge to guide them in making the right decisions.

MentorNect aims to make mentoring easily accessible to young adults to improve

their wellbeing and provide the adequate skills required to thrive on their career journey. To obtain this, the charity recognises the need to strengthen and broaden its strategic collaborations with tertiary institutions; together identify young adults who lack the social capital and guidance to succeed in order to increase their chances of improving their employment prospects.

Additionally, the charity is keen to establish a collaboration with another small charity that aligns with the vision of MentorNect. The alliance will encourage shared knowledge and resources, promote awareness of the Charity, and most importantly, lead to greater impact and effectiveness. Trustees are exploring a potential alliance with Women4WomenEmpowerment, a charity which seeks to equip women with key skills to bring about societal change. The alliance would see MentorNect be the first point of contact for mentee referrals, collaboration on informative and educational webinars.

Trustees seek to have the mentor recruitment as an on-going basis to boost the Charity's mentor portfolio and to minimise the risk of mentor shortages. Fellow charity volunteer recruitment platform will be utilised to achieve this goal. Trustees intend to maintain its existing process such as requiring DBS checks for mentors prior to mentee matching, use of the charity portal and issuing of organisational email log-ins to exercise risk management.

VOLUNTEERS

The trustees would like to take the opportunity to show appreciation to all its volunteers who give up their time in the capacity of mentors, and to our marketing team who work tirelessly to ensure that through our social media

platforms we are adding value to the lives of many young people through our content.

FINANCIAL REVIEW

Trustees are responsible for the preparation, accuracy and keeping of the Annual Accounts in line with SORP guidelines and Charities Act 2022.

In its first year, the charity's total unrestricted funds amounted to £5009 which was dedicated to its set up and to cover its initial costs. A total expenditure of £4136 was incurred with the majority of funds allocated to legal costs to assist with structure of key policies and the Charity's CIO registration. Further information on expenses is elucidated in the Financial Statements. The Charity did not receive any restricted funds in this period. A net of £874 is carried forward as unrestricted funds.
