### Structure, governance and management

The Food Forest Foundation is constituted as a CIO under a constitution dated 23<sup>rd</sup> August 2021.  
New Trustees are appointed by resolution of the existing Trustee body.

### Objectives and activities

#### Objects

To promote for the benefit of the public the conservation, preservation and improvement of the physical and natural environment using methods that sequester carbon from the atmosphere including (but not limited to) agroforestry, forest gardens and food forests

#### Main activities

Our main activity is to give grants to food forest and forest garden projects, primarily grants to fund the planting of such projects.

### Achievements and performance

The charity has not started to achieve its aims because of a lack of funding. Without funds coming in clearly there can be no grants given out. We are hoping for some significant funding in the next year.

### Financial review
